## **Planning**

- **Current Development**

- **Transportation Projects**

Please join us at 6pm, Thursday March 28<sup>th</sup>, 2024, at the Chapel Hill Library for a community conversation with Leah Shahum, founder of the national [Vision Zero Network](#). We will hear how our commitments to Vision Zero and Safe Routes to School can improve safety on our roads, sidewalks and greenways. Shahum brings two decades of experience championing movements to advance safe, healthy, active transportation, and is considered a leader in advocating for safe streets for all.

- a. [Estes Drive Bike-Ped Improvements](#) – Construction is nearing completion, and the job is expected to finish up in spring 2024. More details can be found on [the project webpage](#).
- b. [Estes Drive Extension](#) – This project will construct bicycle and pedestrian improvements from Martin Luther King Jr. Boulevard to the railroad, where Carrboro has a similar project to continue to the end of Estes Drive Extension. The Town is finalizing scope of work with design firm and will kick off the project in the spring.
- c. [Bolin Creek Greenway Extension](#) – This project will extend the existing Bolin Creek Greenway from Umstead Park to Estes Drive Extension. The project design and engineering will be done in conjunction with Estes Drive Extension, which will begin in the spring. Staff will set up a project webpage and listserv in the coming months.
- d. [Cameron Ave Protected Bike Lanes](#) – This project will construct protected bicycle infrastructure along Cameron Avenue between Merritt Mill Road and S. Columbia Street. Staff will begin reviewing proposals for design and engineering services and hope to award a contract later this spring.
- e. [Morgan Creek Greenway](#) – Design for the east segment of the Morgan Creek Greenway from Merritt's Pasture to Oteys Road is funded and underway.
- f. [Homestead Road & Seawell School Road Sidewalk](#) – Construction is currently underway and expected to continue through August 2024. More information can be found on the [Homestead Road Connectivity Project](#) webpage.
- g. [North-South Bus Rapid Transit](#) – The project is currently working on 60% design. The project is recommended for a \$138 million Small Starts grant in the President's FY25 Budget. More information can be found on [the project webpage](#).

- a. **Rewriting Our Rules – A LUMO Update**

    - ii. Council members will continue providing input at Council meetings this spring. The next discussion is scheduled for April 24<sup>th</sup>.

- b. **Water and Sewer Boundary Modification**

- i. The proposal is to expand the water and sewer boundary in the southern part of Chapel Hill along the US 15-501 corridor to the Chatham County line. The service area is commonly referred to as the Urban Service Boundary and is subject to the Water and Sewer Management, Planning Boundary Agreement (WASMPBA).
    - ii. Chapel Hill Town Council, as well as the Town of Carrboro, Town of Hillsborough, and Orange County Commissioners, have endorsed the proposal. OWASA is expected to act on the proposal at their board meeting in April.
