### Project Overview

- Taft Mills Group, on behalf of Lawler Development Group, LLC (Owner), requests a rezoning to Residential–Community Priority–Conditional Zoning District (R-CP-CZD) for their project, "MLK Affordable Housing".
- The site includes three parcels with the following addresses: 607, 609, 611, 613, 615, and 617 Martin Luther King Jr. Blvd and 121 Stinson Street.
- The project fronts on Isley Street and Martin Luther King Jr. Blvd. It offers much needed affordable housing in the future North-South Bus Rapid Transit (BRT) corridor.
- The developer proposes a 100 percent income-restricted multifamily development between 180 and 200 units with a mix of 1- and 2-bedroom units. All units will be in a single six-story building.
- All units would be made available to households with incomes at or below 60 percent of Area Median Income (AMI). This meets the affordable housing criteria of the R-CP-CZD.
- The R-CP-CZD is a streamlined development review process that allows applicants to provide less detailed materials than is typically required in other conditional zoning district applications.

The EV-capable commitment is less than Council's expectation of 1 space per unit; however, staff finds these commitments are suitable for this project because: (1) the affordable housing project is located on a transit line and walkable to downtown, and (2) EV-capable is a more expensive commitment within a parking deck.</li> </ul>

***Public Engagement***


