WHEREAS, the Council created the Percent for Art Program in 2002 and amended the program through the (2025-10-22/O-3) ordinance; and

PROPOSED PERCENT FOR ART PROJECTS FOR FY2026

Staff propose the following on-site Percent For Art (PFA) projects be designed and launched this fiscal year with relevant departments and staff work groups:

- Cedar Falls Tennis Court Reconstruction \$25,000 artistic gate, spring 2026, with Parks & Recreation;
- Community Center Climbing Wall Replacement \$7,000 mural, spring 2026, with Parks & Recreation;
- Fordham Side Path \$20,000 ground plane art, spring/summer 2026, with Parks & Recreation;
- Streets & Sidewalks \$10,000 in PFA funds with hopes of leveraging \$40,000 of federal funds for Safe Routes to School ground plane art, spring/summer 2026, with Office of Mobility.

PROPOSED PERCENT FOR ART REPAIRS FOR FY2026

Staff propose to use a total of \$19,000 of Penny for Parks PFA funds to repair and repaint 12 public artworks along Bolin Creek Greenway that were damaged by Tropical Storm Chantal.

PERCENT FOR ART PROJECTS UNDER CONSIDERATION FOR FY2027

Staff are considering the feasibility and design of the following potential PFA projects for Town Council's review in the FY2027 Annual Percent For Art Plan:

- Ephesus Church Sidewalks \$22,000 PFA budget anticipated for Safe Routes to Schools ground plane art, with Office of Mobility and Public Works Department;
- Bolinwood Bridge budget and design of project TBD, Public Works Department.
