Portions of Town-owned property in the public right of way (following NSBRT's construction) will be deeded to NCDOT. Access agreements will be executed with UNC for stations constructed on state-controlled property; there will be no ownership transfers for those properties. Not all parcels on this list require right of way acquisition. Many require only a temporary easement during the project's construction. Some parcels require more than one acquisition type (i.e., right of way and a drainage easement), which is why the total number of acquisitions is higher than the total number of potentially impacted parcels.
