## **COA SUMMARY**

The applicant, David Swanson on behalf of UNC Chapel Hill, requests a COA for:

- New steel fencing in a traditional black finish, 4'-0" high, joined to existing fencing to provide a continuous, secure perimeter enclosure around the site.
- New decorative steel gates in a traditional black finish: 1 double pedestrian gate at the main entrance walkway, 1 vehicular gate at the far end of the driveway, and 1 pedestrian gate next to the vehicular gate in the driveway.
- New 4' high fieldstone piers at the main entrance walkway.

### **EXISTING CONDITIONS**

The proposed location is zoned Office/Institutional-4 (OI-4) and is in the Franklin-Rosemary Historic District.

## **BACKGROUND**

May 14, 2024	The applicant submits a COA application for the work described above.
July 1, 2024	Staff administratively approves a COA for the driveway turnaround,
	stone piers at the end of the drive, as well as a bluestone steppingstone
	path adjacent to the new piers.

#### DISCUSSION

The Commission should discuss whether the work proposed by the Applicant is or is not incongruous with the special character of the Franklin-Rosemary Historic District. The Applicant has plans, renderings, and photos of the fences, gates, and turnaround area, their materials, and locations, which the Applicant asserts shows that the proposed project is not incongruous with the character of the Franklin-Rosemary Historic District.

If the COA is granted for the exterior change, the applicant would then be required to obtain any necessary zoning compliance and building permits from the Town.
