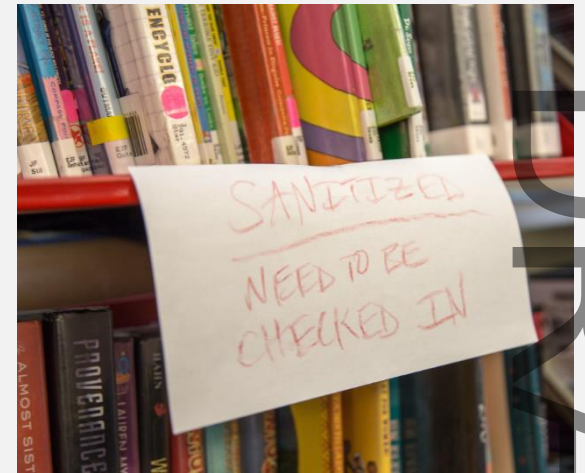
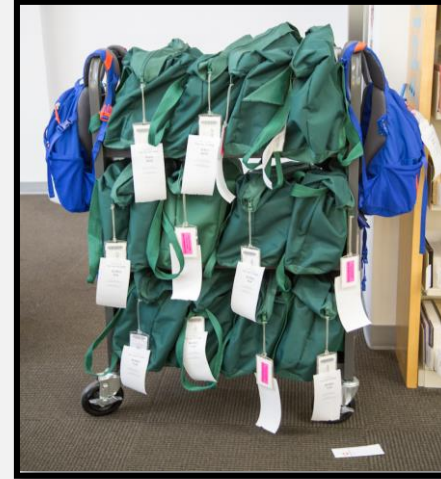

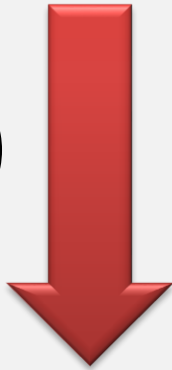

General Fund Impacts

- Department fees (\$1.5M)
- Occupancy taxes (\$579K)
- Fund balance appropriation (\$2.4M)



- Sales taxes +\$1M
- Property taxes steady
- End of 3rd quarter spending @ 67.5% vs 72% prior year
- Personnel savings = \$1.5M
- Operating cuts = \$1.2M

FY 2021 Budget Takeaway

Goal: To break even for the fiscal year

Challenges:

Erratic revenue patterns = difficult projections for next year

Deferred maintenance & operating costs trend higher each year

Continuing COVID-19 operational and financial impacts

Result:

Ability to address deferred needs and implement recovery efforts will require funding

Revaluation Overview

- Revaluation: “right-sizing” tax bills due for FY 2021-22
- Governments publish “revenue-neutral” tax rate for transparency
 - The revenue-neutral rate is the tax rate at which the total value of our property tax collections is the same as the previous year.
 - If property values go up overall, the revenue-neutral rate would go down, and total collections would be the same.
 - The Town is not required to adopt a revenue-neutral rate.
 - It will be difficult for the Town to take on new initiatives if we roll back to the revenue neutral tax rate.

- Cumulative impact of rolling back to the revenue neutral tax rate:
 FY 2010 = \$60,790,688 FY 2018 = \$5,277,246

American Rescue Plan Act of 2021

- \$1.9 trillion stimulus plan
- Coronavirus Local Fiscal Recovery Fund - \$130.2 billion
 - Direct to counties, metropolitan cities, local government
 - Restricted to certain recovery uses
- Chapel Hill's anticipated allocation - \$10.41 million
