Dear Members of the Board of County Commissioners:

I am writing this letter in support of the Orange County Library Task Force recommendations for Orange County library funding and interoperability.

As Chair of the Chapel Hill Public Library Advisory Board, it was an honor to serve on the task force and to participate in the thoughtful discussion and sharing of history and ideas around the provision of library services to the residents of Orange County. Our thoughtful and thorough discussion of equitable funding and possible interoperability resulted in a clear consensus for our recommendations.

***Orange County Library Funding***

There was unanimous agreement that funding for all Orange County libraries should be both equitable and sustainable. Our recommended funding formula would allocate funding based on population, recognizing the fact that all Orange County residents are taxpayers and should receive the equal benefits of that funding. Additionally, using population as a measure is clear, transparent, and easy to assess. Because this funding approach would substantially increase the amount of existing Orange County library funding allocated to the Chapel Hill Public Library, members of the task force acknowledge that achieving an equitable percentage would require some time and recommended a phased-in approach with regular increases over a six year period.

***Interoperability***

Our discussions on interoperability were also fruitful, starting with efforts to define the different types of interoperability. After a lengthy group discussion with information from the directors and staff of the Chapel Hill Public Library and the Orange County Public Library, we agreed that combining operating systems was neither desirable (in terms of increasing access) nor cost-effective (given the potential increase in staff resources required). We felt the best opportunity for interoperability remains with continued communication and coordination between Chapel Hill and Orange County staff about services, policies, best practices, and public programming.

Thank you for your appointment of this task force and for the opportunity to study these large issues. Having been a member of the Chapel Hill Public Library Advisory Board who has looked at the issue of a thoughtful, equitable, and sustainable formula for county library funding (with an initial recommendation dating back to December 2019), I am thrilled at the progress that is being made on this topic. I am also greatly encouraged by the level of commitment and support that was apparent by all who participated in the work of the task force. I appreciate your time and dedication to the importance of library services across all of Orange County and I encourage you to move forward with these recommendations.
