I am an out-of-state student (at UNC Chapel Hill), person of color, South Asian American, activist, and advocate. I can bring a fresh perspective to the Community Policing Advisory Committee as I have lived in Chapel Hill, and yet I have not lived here all of my life. I am from a similar suburb in New York, lending credibility to my membership with the Committee, but allowing a fresh face into the Committee can ensure there is diversity in thought, especially as Chapel Hill is a bona fide college town; many out-of-state students, or at least students not originally from Chapel Hill, will live here and be protected by the same municipal police department, so representation from these students is critical. As a person of color, I have a unique lived experience and understand the world differently than many of my peers, especially as UNC Chapel Hill is a predominantly white institution. Representation of people of color in local governance is vital to ensuring that the police are fair and just for all. Adding to that, I am a South Asian American, which is a unique minority group. Asian Americans are the largest minority group on campus, and we can further inclusion of Asian American, and South Asian American, individuals through greater representation in local boards like the Community Policing Advisory Committee. It cannot truly represent the community if not all voices are heard. I am a passionate activist and advocate, championing numerous important causes here and in New York. One of the most important causes I strive to fight for is civic engagement, especially among the youth. Young Americans are the future of our country, and yet often, the government at the local, state, and federal levels neglect the youth. Young Americans must have a voice at the table and can enter the marketplace of ideas, and my presence on the committee would further this. Overall, I would bring valuable perspectives to the committee, and I am confident I would be an asset and I would be a fervent representative of my community. Chapel Hill is my home, and I will fight to make it the best home it can be, especially in the space of police and community relations.

In addition, members of the Historic District Commission and Board of Adjustment, when these boards are hearing cases, serve as quasi-judicial bodies. Pursuant to General Statute 160D-109(d), members of these boards "shall not participate in or vote on any quasi-judicial matter in a manner that would violate affected persons' constitutional rights to an impartial decision maker. Impermissible violations of due process include, but are not limited to, a member having a fixed opinion prior to hearing the matter that is not susceptible to change, undisclosed ex parte communications, a close familial, business, or other associational relationship with an affected person, or a financial interest in the outcome of the matter." Any member who violates these Ethics Guidelines may be subject to removal from the board or commission. If the advisory board or commission member believes he/she has a conflict of interest then that member shall recuse himself/herself from voting on the matter. In cases where the individual member or the advisory board or commission establishes a conflict of interest, then the advisory board or commission member shall remove themselves from the voting area. Any advisory board or commission member may seek the counsel of the Town Attorney on questions regarding the interpretation of these ethics guidelines or other conflict of interest matters. 

ETHICS GUIDELINES FOR TOWN ADVISORY BOARDS AND COMMISSIONS

Members of advisory boards and commissions shall not vote on any matter in which they have a conflict of interest or an interest which reasonably might appear to be in conflict with the concept of fairness in dealing with public business. A conflict of interest or a potential conflict occurs if the outcome of the matter being considered is reasonably likely to have a direct, substantial, and readily identifiable financial impact on the member. In addition, members of the Historic District Commission and Board of Adjustment, when these boards are hearing cases, serve as quasi-judicial bodies. Pursuant to General Statute 160D-109(d), members of these boards "shall not participate in or vote on any quasi-judicial matter in a manner that would violate affected persons' constitutional rights to an impartial decision maker. Impermissible violations of due process include, but are not limited to, a member having a fixed opinion prior to hearing the matter that is not susceptible to change, undisclosed ex parte communications, a close familial, business, or other associational relationship with an affected person, or a financial interest in the outcome of the matter." Any member who violates these Ethics Guidelines may be subject to removal from the board or commission. If the advisory board or commission member believes he/she has a conflict of interest then that member shall recuse himself/herself from voting on the matter. In cases where the individual member or the advisory board or commission establishes a conflict of interest, then the advisory board or commission member shall remove themselves from the voting area. Any advisory board or commission member may seek the counsel of the Town Attorney on questions regarding the interpretation of these ethics guidelines or other conflict of interest matters. The interpretation may include a recommendation on whether or not the advisory board or commission member should excuse himself/herself from voting. The advisory board or commission member may request the Town Attorney respond in writing.
