**DISCUSSION**

**7. Authorize the Town Manager to Execute a Brownfields [\[25-0116\]](#)**

Agreement with the North Carolina Department of Environmental Quality for the Police Station Property Located at 828 Martin Luther King Jr Blvd.

Interim Town Manager Mary Jane Nirdlinger announced that the Town had received a signed Brownfields Agreement from the North Carolina Department of Environmental Quality (NCDEQ) concerning the contaminated property at 828 Martin Luther King Jr. Boulevard.

Community Sustainability Manager John Richardson highlighted the various meetings held with the Town and NCDEQ since 2021 regarding remediation and redevelopment of the site clarifying the agreement did not dictate future development plans, but outlined permissible uses. Mr. Richardson recommended that the Council adopt Resolution 7, authorizing the Town Manager to sign the Brownfields Agreement, and outlined the subsequent steps through June 2025.

Nick Torrey, a senior attorney from the Southern Environmental Law Center representing Friends of Bolin Creek, expressed concerns about the presence of arsenic and cadmium in coal ash, as identified by the U.S. Environmental Protection Agency (EPA). He noted that the EPA's report

was released a month after NCDEQ approved the Brownfields Agreement and that the Southern Environmental Law Center had previously raised these issues. Mr. Torrey argued that the site was unsuitable for a Brownfields project and urged the Council to pursue a comprehensive clean-up plan.

Julie McClintock, co-president of Friends of Bolin Creek, recounted her group's advocacy efforts since 2014, emphasizing that NCDEQ had not considered the new findings about cadmium and arsenic. Isabel Geffner, a Chapel Hill resident, described the issue as a matter of life and death and stressed the importance of heeding Torrey's advice, given his expertise in coal ash.

Council asked Mr. Richardson to provide clarification on the flexibility of the Brownsfields Agreement. Mr. Richardson confirmed that the agreement allowed a range of remediation options, and assured the Council that signing the agreement would not prevent the Town from considering new evidence or collaborating with experts like Mr. Torrey. Mr. Richardson reviewed the Town's effort since the 2013 coal ash discovery, including measures to create a barrier between the contaminants and the public.

The Council agreed to sign the Brownfields Agreement, emphasizing their commitment to understanding the EPA report and engaging in public discussions. They also expressed concerns about transporting coal ash to other communities and requested additional information on this aspect.

A motion was made by Council Member Stegman, seconded by Council Member Berry, that the Council adopt R-7. The motion carried by a unanimous vote.

**8. Open the Public Hearing and Consider a Request to Close the Public Right-of-Way Portion of Huse Street.**

Engineer Robert Gehris presented a 2024 request to close the Huse Street right of way (ROW). This request was linked to the Chapel Hill Crossing, a multi-unit residential building at 5500 Old Chapel Hill Road, which the Council approved in 2023. Mr. Gehris reviewed the completed steps and the appeal process, showing the ROW's location on an area map and providing background on the Huse Street area.

Mr. Gehris noted neither the Town or Orange Water and Sewer Authority (OWASA) had a need for the ROW. He mentioned that staff had notified adjacent property owners, receiving no objections except from Mr. Koeyler, who had previously addressed the Council (Item 0.03). Mr. Gehris recommended that the Council open and close the public hearing and consider adopting Resolution 8 to permanently close the ROW.

The Council and developer Ernie Brown discussed the possibility of delaying the closure to accommodate Mr. Koeyley's needs. Mr. Brown indicated that while he might be able to consider a delay if there was extra time, his contract required him to submit all permits by the end of May. He pointed out that NC law mandates only a 30-day notice for month-to-month tenants, and he had provided almost 90 days. Additionally, he had offered tenants a moving allowance and a return on their deposits.

Council discussed the implications of delaying the process. Town Attorney Ann Anderson explained that NC General Statute permits the Council to close a street if it is not contrary to the public interest and no nearby property owner would be deprived of access.

Chapel Hill resident Liv Hutchby addressed Council, noting that World Water Day was approaching on March 22, 2025. She urged Council to be mindful of how the Town and County make decisions involving water resources.

A motion was made by Council Member Stegman, seconded by Council Member Berry, that the Council adopt R-8. The motion carried by a unanimous vote.

**9. Open the Public Hearing to Consider a Request to Close Portions of the Public Right-of-Way in Cowan Boulevard and White Oak Drive**

Engineer Robert Gehris presented a request to close a portion of White Oak Drive and parts of an undeveloped right of way (ROW) known as Cowan Boulevard. He displayed the location on an area map and explained that the request was related to the Meridian Lakeview project, a multi-unit residential development that will include 316 apartments. Mr. Gehris noted that neither the Town nor OWASA a need for the ROW.

Mr. Gehris reminded Council the Town approved a Conditional Zoning for the same project in 2023, known as Gateway Development. He noted staff notified adjacent property owners and had received no objections. He recommended that Council open and close the public hearing and consider adopting Resolution 9, which would permanently close the ROWs.

A motion was made by Mayor pro tem Ryan, seconded by Council Member Miller-Foushee, that the Council adopt R-9. The motion carried by a unanimous vote.
