In my role as the Vice President of Homeowner Services at Habitat for Humanity, I witness firsthand the pressing need for safe and affordable housing in our community. Over the past two years alone, we have received nearly a thousand applications from individuals and families seeking assistance through our program. The sheer volume of these applications

underscores the gravity of the situation – there are countless individuals who are struggling to find housing that they can afford in Chapel Hill.

Allow me to share just one of the many poignant stories we encounter daily in our Homeowner Services Department. One of our recent homebuyers, an executive assistant at Chapel Hill Carrboro City Schools, was paying an exorbitant \$1,660 per month just to live close to her workplace. This amounted to over 45% of her monthly income, an unsustainable burden by any measure. Despite living in Chapel Hill for over two decades and being an integral part of the community, her financial situation made it nearly impossible for her to secure stable housing. However, after being denied twice for our program, she persevered and was finally approved in the fall of 2023. Now, she and her husband are eagerly anticipating the opportunity to purchase a home in Habitat's newest development at Weavers Grove, where they can finally enjoy the security and stability of affordable homeownership.

This story is emblematic of the struggles faced by many in our community. It serves as a stark reminder of the urgent need for affordable housing initiatives like the proposed bond. As you deliberate on the future of this bond at the upcoming Town Council meeting on April 25th, I implore you to keep the needs of individuals like our homebuyer in mind.

Affordable housing is not a luxury, but a fundamental necessity for the well-being and prosperity of our community. By prioritizing the allocation of funds towards affordable housing initiatives, we can ensure that hardworking residents and employees have access to the basic human right of safe and stable housing.

I urge you to take decisive action and prioritize placing the housing bond on the 2024 ballot so that voters can have a say in shaping the future of our community. While I recognize that there are competing priorities, I firmly believe that investing in affordable housing is a critical first step towards building a more equitable and inclusive Chapel Hill.

I am writing to encourage you to please put the \$50 million referendum bond on the ballot this calendar year and not wait until 2025. We know what the needs are and we know they are urgent. Putting this bond off for another year is simply not acceptable. We at HOPE NC are so grateful for your adoption of the Affordable Housing Plan and Investment Strategy because there are so many individuals with disabilities who will never be able to live alone without the creation and preservation of affordable housing. Living on an income of SSI, even if you are working part-time, means that it is impossible to afford housing in good times but especially with the cost of housing today. We are about to be in a crisis with all of the caregivers who are over age 60 not being able to take care of their adult loved ones with intellectual and developmental disabilities soon. We need to increase the supply of affordable housing and we all know how long that typically takes to build, so it needs to happen now. I also urge you to consider at least \$30 million of the bond going towards affordable housing. While \$10 million seems like a lot of money, it will nowhere near fund what we need to add to the supply of affordable homes while at the same time providing adequate salaries for housing staff, money for home rehabilitation and preservation of the affordable units we already have.

Please put the bond on the 2024 ballot and please fund affordable housing with at least \$30 million.

Thank you for all the work you do to make Chapel Hill the great place it is to live. I want to make sure that everyone who has a disability and lives with their parents in Chapel Hill can afford to live on their own and not have to go into an institution due solely to the cost of the available homes!

Dear Mayor and Town Council of Chapel Hill,

I'm writing in regards to the current state and future of the CHCC climbing wall. As you are likely aware, the <u>CHCC climbing wall is continuing to be actively used and has been for over 30 years</u>. The relatively small footprint of the climbing wall has been a significant community-builder and a huge success towards the mission of the Community Center and Chapel Hill Parks and Rec: *it brings people together and promotes a healthier, more livable community*. We have built friendships, lifelong relationships/ partners, and support networks from climbing at the CHCC.

I moved to Carrboro 13 years ago for work and during my first month a co-worker introduced me to the sport of rock climbing at the CHCC. I was immediately welcomed into the most gracious, generous, and supportive network I have ever known. This is not an exaggeration. I met my husband at the CHCC climbing wall; friends from the CHCC climbing wall were in our wedding; one CHCC climbing friend married my sister and is now my brother-in-law; some are listed on emergency forms for our kids' schools. We now bring our kids to the wall to climb and are teaching them perseverance, that growth and learning occur from being challenged and trying new ways of movement, the mental and physical benefits of exercise, and the value of the outdoors that come with this unique sport.

The wall being located at the CHCC allows the entire Orange County community to access a new Olympic sport. Perhaps a gold medal will one day originate from the CHCC! It's on a bus route, has biking paths linking to other parts of town, free parking, and to climb only costs about \$5 (compared to 5x all the way in Durham). Being at the CHCC is wonderful for families with young kids because of the playground. Being indoors allows for physical activity during the peak summer heat and the ability to use the space in all kinds of weather. There is an active youth engagement through the youth climbing club. The CHCC climbing wall makes climbing approachable and accessible to anyone, seasoned climbers and first-time attempts.

The CHCC has done all they can for upkeep of the ropes, safety gear, and climbing holds. But the wall itself is in dire need of replacement. For this <u>existing structure currently in active use by the local community</u>, I am requesting that Town Council support and prioritize investment in the CHCC climbing wall with the bond.

The current bond proposal suggests a very small portion of the overall bond value to be allocated to Recreation Facilities, with the climbing wall noted as a priority project and only needing a fraction of the suggested allocation. It would be a loss for the Community Center, and Chapel Hill, if the climbing wall were allowed to continue deteriorating. Please retain the CHCC climbing wall as a priority project. The Federal Register published the Department's <u>final rule</u> under Title II of the Americans with Disabilities Act (ADA), which applies to State and local governments, to improve web and mobile application (app) access for people with disabilities. The rule clarifies how State and local governments can meet their existing ADA obligations as many of their activities move to the digital space. This rule, <u>signed by the Attorney General</u> earlier this month, adopts a technical standard for web and mobile accessibility to ensure that people with disabilities can better access important public services like health care, voting, and education.

With today's publication, the dates by which State and local governments have to comply with the rule's requirements are now finalized. State and local governments with a population of 50,000 or more will have to be in compliance with the rule's requirements beginning on April 24, 2026. State and local governments with a population of less than 50,000, as well as special district governments, will have to be in compliance beginning on April 26, 2027. This means that State and local governments' web content and mobile apps will have to generally meet the technical standard in the rule by these dates and on an ongoing basis after these dates.

In the meantime, State and local governments still have existing Title II obligations. This means that even before the compliance dates, State and local governments must provide people with disabilities equal access to their services, programs, and activities offered via the web and mobile apps.

For a high-level summary of the final rule, read the <u>fact sheet</u>. Individuals can also find the official version of the full rule in the <u>Federal Register</u>. The Department also plans to issue a Small Entity Compliance Guide to assist small State and local governments in complying with the rule.

Good afternoon Councilmembers,

My name is Quinton Harper. I'm a resident of Carrboro, and I write to you today asking you to place the bond on the ballot in 2024 and to allocate \$35 million to affordable housing. Additionally, I'm also asking you to commit a full two cents of the tax revenue to affordable housing.

I understand that there are a lot of competing interests and community needs., most pressing of these, I believe, is that people need a roof over their heads and housing that's affordable. Without significant government investment, the number of people who are homeless will continue to increase and the gap in affordable housing units available will widen and continue to fall drastically short of the need. Because the rent is so high and outpaces the growth in wages and earnings, increasingly more and more people in our community are housing cost-burdened and struggling/unable to make ends meet. This, we know, is a violent system of capitalism that puts profit over people and keeps many in our community trapped in poverty and unable to stabilize and advance economically. I believe, and I hope you will agree, that government has a significant role to play in calling out and providing a remedy for the opportunities historically denied to Black folks and poor folks, a role to play in affirming equality and a role to play in advancing us towards equity so that every member of our community has their basic needs met (ie: a roof over their head, food to eat).

You already know from the adopted Affordable Housing Plan and Investment Strategy that the Town recognizes a \$50 million dollar funding gap for affordable housing over the next five years. Friends - I ask you to consider that equity looks like putting the bond on the 2024 ballot with \$35 million dollars earmarked for affordable housing, and letting voters decide. This is a step towards advancing equity because it will enable nonprofits and community members to access the funding to help meet the needs of our community, in the face of being denied access to these opportunities historically. Again, providing affordable housing, in particular for those at 30% AMI and below, requires significant investment from our local government partners.

In my role as Executive Director for Pee Wee Homes, it's important to share that roughly 69% of the cost to build three new homes supporting people transitioning out of housing insecurity (Hill Street in Carrboro) has come from Orange County and Carrboro. That support has been critical in building these homes -- homes where residents pay no more than 30% of their monthly income on rent, and it has enabled us to increase our stock of deeply affordable housing from 7 to 10. The mission of Pee Wee Homes to build dignified and affordable tiny homes in caring communities can possibly continue in a big way. The investment of \$35 million dollars for affordable housing over the next five years is \$6 million dollars each year, as opposed to \$2 million dollars, which would be the case if the portion of the bond for affordable housing is reduced to \$10 million dollars over the next five years. With \$35 million for affordable housing, the vision to house and support elders in our community, can grow and expand in a significant, meaningful and impactful way, and could stretch our imagination to our wildest dreams. Imagine a tiny home community that houses and supports elders who are veterans, to transition out of homelessness. I don't want to make any commitments on the behalf of Pee Wee Homes, but we know that folks in our community, folks like Darin Campbell and Minister Robert Campbell have elevated this vision to meet that need.
