and researched applications and arrived fully prepared in a way few others have; he contributed immeasurably to the work of the commission, including the revised-guidelines project. The Historic District Commission will be fortunate to have John Sweet on the commission for another term.

I am familiar with Anne Perl dePaul's remarkable credentials as an architect and preservationist and the endorsements she received from qualified sources last October. She has so much to contribute: experience working in preservation, a sense of history, and design-evaluation skills. Anne and I met in the neighborhood recently, and I learned from our brief meeting that she is eager to serve her community, her hometown, as a commissioner on the HDC.

The historic districts of Chapel Hill are important to the residents of the districts, the citizens of Chapel Hill, the University, and all of North Carolina. The historic *character* of the districts is a precious asset that the commission is charged with both protecting and overseeing appropriate renovations. We need qualified commissioners who understand this charge and are willing to take on the responsibility. For this reason I support the appointment of Anne Perl dePal and John Sweet.
