DISCUSSION

7. Presentation: Recommended Budget for FY 2025-26

[25-0215]

Interim Town Manager Mary Jane Nirdlinger presented the FY 2026 Recommended Town Budget, highlighting the significant decline in sales tax revenue, continued funding priorities in the five-year budget strategy and Complete Community Framework, and addressed the increased costs of carrying out Transit services.

Ms. Nirdlinger recommended a total budget of \$163,672,372, which

included \$94.9 million for the General Fund, property tax rate of 50.0 cents, which would be 5.8 cents over revenue neutral and included a 0.3 cent increase for Transit with a chart that showed the impact of that tax rate on homeowners' taxes at various levels.

Ms. Nirdlinger stated the recommended budget included a 5% pay increase for Town employees, placing \$1,517,000 toward operating budget focus areas, and recommended increases to retirement system and medical insurance, funding for an employee pay and class study, and three new positions.

Ms. Nirdlinger discussed revenue trends that had affected the budget, such as receiving lower income from sales tax and permits, a plan to reduce General Fund balance to account for less personnel savings each year, and the General Fund's 5-year outlook and the variables that could affect revenues addressing the rising cost of doing business and the cost of expanding services, maintaining facilities, resurfacing streets, and replacing fleet.

Ms. Nirdlinger noted that the budget included \$5,023,818 in annual commitments to affordable housing partners, the Town's Climate Action Plan, Everywhere to Everywhere Greenways, and performance agreements with outside agencies. She reviewed the status of the Town's Transit, Parking, Public Housing and Stormwater funds and provided Council with a schedule of the remaining budget discussions.

Council discussed and asked questions around sustainability, additional information about the proposal to keep funding flat for outside partners, seasonal employees raise, restructuring of Town departments, and UNC and Carrboro's contributions to Chapel Hill Transit as well.

George Barrett, Executive Director of the Marian Cheek Jackson Center, spoke about the importance of maintaining the commitment the Town had made when adopting its Affordable Housing Plan and Investment Strategy.

Kristina Smith, a UNC student, pointed out the strong impact that funding for affordable housing had on poverty, drug use and violence.

Jackie Jenks, Executive Director of the InterFaith Council (IFC), said that it was demoralizing to hear a flat funding recommendation at a time when community programs were becoming even more necessary.

Council stated the need to have more conversations around the budget strategy to ensure the Town is a sustainable organization, and that decisions are sustainable for taxpayers and residents.

Vice President of Development at Taft Mills Group, Nate Broman-Fulks, presented a rezoning application for Hillside Trace, an affordable housing project that would be developed in partnership with Community Home

Trust. He pointed out that Taft Mills Group was the same development company that had built Tanyard Branch Trace and Longleaf Trace, two AH projects in Chapel Hill.

Mr. Broman-Fulks showed the 3-acre site on a map, noted its proximity to a future bus rapid transit route and Downtown Chapel Hill with approximately 190 affordable housing rental units, the most affordable housing in a single development in the Town's history.

Mr. Broman-Fulks discussed a proposed mix of 1-, 2- and 3-bedroom units on four floors with structured parking and amenity spaces below, showed architectural renderings of how the project would look from various directions, and plans to activate the outside space and architectural elements that would be used to address scale.

Senior Planner Katherine Shor said that staff had found the request to rezone the property from Residential 4 to Residential-Community-Priority-Conditional Zoning District (CZD) to be in alignment with Complete Community goals and the Comprehensive Plan. She recommended Council approval subject to conditions in Ordinance 2 and pointed out that CZD allowed opening and closing the hearing in same evening noting the Planning Commission recommended approval with a condition that the applicant continue working with the Town's urban designer.

Council members asked about the balance between workforce and student housing, confirmed Hillside Trace would be a tax credit project that would require some subsidy from the Town's Affordable Housing Fund, and verified that bike parking would meet LUMO requirements and would include e-bike charging spaces.

Dane Schuckman, a 620 Martin Luther King, Jr. Boulevard resident, asked the Council to be mindful of how the development could affect him and his neighbors.

A motion was made by Council Member Stegman, seconded by Council Member Nollert, that the Council closed the public hearing. The motion carried by a unanimous vote.
