Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA’s mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Demolition is complete. A development partner, Community Housing Partners, has been contracted and a groundbreaking took place in June 2024. Construction work is making good progress. AH & CC plans to explore (RAD) as an asset repositioning tool for other neighborhoods.</p> <p>Units with Approved Vacancies for Modernization</p> <p>In tandem with our Public Housing Master Plan, and our major appliance replacement schedule, we continue to replace furnaces, water heaters, ranges, and refrigerators according to appliance lifespans.</p> <p>The following units have been identified as requiring extraordinary maintenance that will require capital funding to cover contract costs. They are: 355 S. Estes (extensive mold remediation), all 12 buildings in the Rainbow Heights community (foundation and porch repairs), siding at Oakwood, Eastwood and other units within the portfolio. The Town plans to use capital funds for modernization activities across the entire portfolio.</p>

<p>B.3</p>	<p>Progress Report.</p> <p>Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year and Annual Plan.</p> <ol style="list-style-type: none"> 1. <u>Achieve and maintain high performer status as evaluated by HUD in their Public Housing Assessment System (PHAS) for the public housing program.</u> <p>Maintain 96% or higher Occupancy Levels: AH & CC operations is working towards 96% occupancy as the minimum standard with the ultimate goal of all maintaining an occupancy rate at 96% and above. With continued emphasis on occupancy and more procurement of contractors along with new skilled staff to modernize and make ready units, the aforementioned goal will be achieved.</p> 2. <u>Continue to focus on all key indicators including rent collection, recertifications, and vacancy reduction along with improved NSPIRE scores.</u> <p>The AH & CC aims to first be a Standard PHA followed by a High Performing designation. In order to improve its performance a focus on organizational excellence will be emphasized. The public housing division shall meet on a regular basis, covering ways to attain PHAS scoring as required by HUD. A work plan has been created, detailing the process of obtaining quarterly goals and objectives that impact key indicators.</p> 3. <u>Formalize asset management staffing and systems within AH & CC's organizational structure.</u> <p>AH & CC senior management convene biweekly meetings to advance this goal. Much of the focus to date has been AH & CC's increasing review of inventory and invoices to aid in tracking of spending. Team development has been a focus point, emphasizing work collaboration among multiple departments within the Town's organization.</p> 4. <u>Preserve and increase supply of affordable housing by continuing its RAD conversion.</u> <p>AH & CC converted one neighborhood: Trinity Court. Craig Gomains is a neighborhood that has been evaluated and identified as the next neighborhood to be converted. This will increase the number of affordable units available in Chapel Hill.. The AH & CC will also preserve its supply of 296 units of affordable housing by adhering to the NSPIRE protocol and making capital improvements to sustain the investments.</p> 5. <u>Use resources to serve low- and very-low income citizens, connecting them with vital community resources.</u> <p>AH & CC continues to use its Council adopted preference strategy to help the most vulnerable citizens in need of stable housing. Working with the Orange County Project to End Homelessness (OCPEH), AH & CC will market vacancies towards the Homeless in Orange County. AH & CC hired a Resident Service Coordinator (RSC) to better fulfill its duty of attracting community agencies to help residents fulfill the community service requirement. The RSC designs and implements programming to improve quality of life. Job readiness training, livable wage attainment, education achievement and homeownership are some areas that may have specialized focus for services. AH & CC will also use its section 3 program to help low- and moderate-income households with practical work experiences and entrepreneurial endeavors.</p>
