We are reaching out to you about the Weavers Grove development zoning change request. We have concerns on the proposal, particularly with regard to tonight's topic of rezoning, and the corresponding increase in density.

We are urging you and the council to reconsider and reformulate this land proposal and to deny the request to rezone this land. Rezoning this to high density does not match the intent for this land, particularly with regard to its surroundings. This land is in and around a rural buffer, intended to transition from low density housing to even further lower density housing. This land has been designated for over thirty years to prevent suburban sprawl and the corresponding challenges (water, noise, traffic/safety) that density brings. This rezoning proposal goes directly against the intent of this land planning, to promote dense living at the boundaries of the city.

Please also consider the surroundings of this land. On one side it is bordered by I-40. Rezoning and constructing the intended high density housing will eliminate essential natural sound barriers to 40. It will allow densely packing people very close to the highway, while also eliminating the structure that dampens the corresponding noise. This will bring a lot of additional noise to a residential area that already has too much. On other sides, it borders Chandler's Green, a low-density residential neighborhood, intended for locations on the boundaries of the city limits. Dense populations belong close to the main parts of the city, where there is easy access, even by walking, to most essentials of daily living. Rezoning and the corresponding dense population will significantly alter the surrounding community, while creating a less appealing living setup for the new residents of this area.

Please reconsider and reformulate this proposal by denying the request for increased density. Thank you for your time and thoughtful consideration.

By adding 100 units affordable to people earning 30% and 80% of the Area Median Income, Weavers Grove will be improving our community's public health, civic participation, and economy while increasing our desirability and competitiveness to prospective employers by creating a supply of housing closer to active economic zones.

The primary objections to the development, on stormwater drainage and traffic grounds, have been thoroughly addressed by Habitat for Humanity and by the Town of Chapel Hill through a rigorous planning process. Adequate measures are in place to manage stormwater in both the construction and post-development phases of the project. The lack of pre-existing high traffic areas north of the Weavers Grove site makes it unlikely that the development would increase congestion in surrounding neighborhoods.

Dear Mayor and Members of the Town Council -

I was moved by the discussion last night around the systemic racism in our society, and applaud the citizens, young and old, who took the time to express their ideas and recommendations during this difficult time. And I appreciate that you allowed people some time to express themselves in an open forum.

Unfortunately, the limited time as well as inability to respond as a council, left me wondering whether these voices have been truly heard, and whether they will have any impact on the actions or policies of the town going forward.

I felt similarly distressed when the very important subject of Weavers Grove came up, at 11:00 PM, after a very stressful and emotional set of topics preceding it. I had spent many days preparing to deliver a concise 3 minute statement, expressing my support of the IDEA of the plan while identifying serious concerns that would normally capture your interest. I was on the Town zoom call beginning at 7PM and waited FIVE hours for the opportunity to exercise this privilege, only to be told at the last minute that I would have only 2 minutes, and then being cut off practically mid-sentence even before the two minute mark without having the satisfaction of either delivering my remarks fully, or being heard by the Council. Breakdowns in technology didn't help matters either, as my internet disconnected moments before my group was called to speak.

Many important issues were raised last night that deserve serious consideration by the council, yet by the time these points were raised, it was past midnight, and most everyone appeared exhausted. The issues are not easy to embrace, yet they are crucial to the success of the Weavers Grove project. I feel they were too easily cast aside last night / this morning.

I supported the 2008 Habitat plan for the development of the Sunrise property, and I support the vision that habitat has for their current plan. There are some wonderful features in their vision for the project. I can't understand, however, that with the research that unequivocally proves that high noise exposure causes serious health issues going well beyond hearing loss, and includes diseases and illnesses that shorten people's life expectancies, I can't understand how any council member is willing to push this plan forward right now.

I appreciate the desperate need for affordable housing in Chapel Hill, but why does that make it right to put residents' health at risk? They look to you, councilmembers, as policy makers to regulate and ensure their safety, not put them in harm's way. How can you move forward so quickly without even appearing to care, without slowing this train down just a little bit, to ensure the health and safety of the very people you are attempting to serve?

You are charged with looking beyond today, and thinking longer term about the ramifications of your decisions. The current Habitat plan takes no accounting for the widening of I-40 and the substantial degradation of the living conditions that will come as a result. There are too many homes, especially affordable housing units, that will be built in unhealthy zones of the property (not to even mention the swampy wetlands and streams beneath them).

I don't want to be harsh, but I honestly view this attitude as shameful. Knowingly putting at risk the lives of the Weavers Grove residents by allowing the developer to put homes in high risk/high noise zones is absolutely shameful-and it ignores the science. I have learned to expect this behavior in Washington DC, but not among our own council members in Chapel Hill.

Two hours of last night's meeting were spent hearing of the racial inequities that have systemically plagued our policing institutions. We fully know, too, that these same injustices have plagued our housing authorities and countless other key segments of our society. Why are you still advocating for putting our lower earning population in the swamp right along the highway? Is there no consideration for equity here?

I hope you understand why I am so distressed, and I hope you will consider these issues. Please slow this process down, enough to gain the proper assurances from the developer that the health and safety of Weavers Grove citizens are a shared priority. There are numerous ways this can be achieved and I hope you will only approve the zoning request after these alternatives are explored and included in this conditional zoning plan.

I watched the Town Council meeting last night in anticipation of item 15, Weavers Grove. I am very concerned about the procedures that took place during this meeting. I am a Chandler's Green resident for over 30 years and have had to defend our neighborhood against big developments being proposed next to our small neighborhood of 81 homes set among trees. I am not against Habitat for Humanity and would love to be proud to support this project but I can't when it is being proposed as part of a major development plan.

The procedures that I am complaining about.

- 1) First, the last minute change of this meeting and putting it at the end of a jam packed meeting meant that the Town Council was exhausted (even said so) and were unable to attend to the concerns presented by Chandler's Green neighbors.
- 2) For the 4.5 hours preceding the Weaver's Grove presentation, speakers were told to keep their comments to 2 minutes. It was only after 3 speakers from Chandler's Green spoke very rapidly to say what was prepared for a 3 minute speech, lawyer, Karpinos stated that the speakers could have 3 minutes. Why did he wait until the ¾ of our HOA Board members had spoken.
- 3) The technical difficulties were only experienced by the Chandler's Green neighbors and not the supporters of Habitat. This is just an observation. The technical difficulties made it impossible to make a coherent presentation of Chandler's Green concerns.
- 4) Chandler's Green concerns are being ignored by the Town Council.
- 5) Science is being ignored by the Town Council

The Town Council can turn a blind eye and ear to the decibel levels of previous sound studies and not do a current sound study. This will not absolve them of responsibility of creating a hazardous place for people to live. Without current studies, the Town Council does not know the answers. Require the developer to do the studies before approval.

Trees Trees Trees. I always believed Chapel Hill was a believer in the

value of trees. With all of the development going on it Chapel Hill we will be losing a valuable resource, trees. The trees will be removed first before any construction is done. This alone will increase stormwater and noise pollution before any stormwater and noise pollution is mediated. The application states the stormwater mediation takes place at the end of all the construction which is projected to be about

10 years. I don't know when the berm is planned. Do you? What will happen to our neighborhood in the meantime?

CHALT strongly supports the provision of a wide mix of affordable housing types in Chapel Hill, especially housing for those with the greatest need and fewest resources. We admire the model pioneered by Habitat for Humanity that employs the labor of future homeowners, as well as that of volunteers, to build houses for people for whom home ownership would otherwise be difficult or impossible. The creation of 100 new affordable units at Weaver's Grove will be a significant benefit to the units' future owners and to the community as a whole and will be an even greater benefit if these new homes are located on desirable lots, with appropriate noise control.

Weavers Grove presents unique challenges which have not yet been addressed, but we feel these challenges can be overcome with certain design modifications.

Specifically, this proposal is environmentally and economically unjust because it places the affordable homes on the least desirable parts of the property where future residents are sure to encounter problems because:

- The least desirable places to build are located north of the power line wetlands and RCD in the northwest and pooled standing water in the presently forest northeast quadrant - where the affordable Habitat homes are to be placed.
- Much of the site is covered with power lines, streams and wetlands.
- This northeast area also borders an elevated section of I-40 that is soon to be widened to 6 lanes, which will exacerbate the area's already significant noise and air pollution. https://publicinput.com/l-40-Orange-County
- The limited buildable area of the site is almost entirely covered with a "hard surface" -- streets, parking lots and roofs, which will exacerbate stormwater runoff and contribute to flooding.

Recent advisory board reviews have produced many comments about the density of the plan that will greatly reduce tree cover and increase the chance of stormwater problems. We share these concerns. But, unfortunately these Board reviews come at the end of the development review cycle instead at the start of the review process, when there is little opportunity to remedy obvious problems without requiring a disruptive redesign. For example, the Stormwater Advisory Board discussed at length the concern about the requested RCD exceptions, yet failed to weigh in with a recommendation that might jeopardize the project as it neared the final stage. The Stormwater Board will take up the issue of early review at their next meeting. Further, the Town stormwater staff chose not to enter expert opinion and the neighborhood spokesman had a family emergency so relevant information was withheld from consideration.

Stormwater and environmental issues continue to be considered well after a design is submitted for a permit instead of at the start of the process. Chapel Hill must find a way to include environmental and stormwater discussions earlier in the planning process, if the Town is to create truly sustainable projects. An early review would have prevented the following serious site design problems:

- Stormwater features are located outside of the buildable area and some of the larger stormwater retention basins are placed right in the Resource Conservation District (RCD). The RCD was intended to remain undisturbed in order to function as an additional protection for water quality as well as for ecological conservation and a wildlife corridor. Allowing abundant exceptions undercuts the usefulness of having such an ordinance.
- Stormwater is transported long distances in underground culverts. The stormwater retention design
 does not follow the natural slope and drainage plains of the property. Piping storm water long
 distances repeats the failed Eastgate design of stormwater management. Our Stormwater Board seeks
 daylighting solutions for stormwater. The Chapel Hill-Carrboro Schools administration sought early
 stormwater input which enabled the use of some of these solutions.
- Pervious pavement is used to meet stormwater requirements but we question that it can be properly
 maintained by the Homeowners Association. Most of the "green space" and walking trails are placed
 outside the buildable area, which is dominated by parking lots and immature trees. This contributes to a
 "heat island" effect and a more bleak environment than if the green space and water features had been
 integrated amongst the building units. {See attachment #2 example of high density 751 project.}
- Instead of making use of the natural features, the entire site will be re-graded. Most of the Specimen and Rare trees are removed. There are at least 5 clusters of valuable hardwood on this site. Three of them will be removed if the Town Manager grants an exception to our Canopy Tree Ordinance.)
- The buildings are not oriented to allow solar panel installation. This suggestion was discussed by the Environmental Stewardship Board, but ultimately the Board majority did not want to impede the project or call for a redesign at this late stage even though they liked the idea. These homes will thus depend on ever more expensive electrical power.
- Three townhomes are placed on top of a stream that is now ephemeral but once was considered perennial. A new stream designation would be timely.
- Ten of the homes placed very close to I-40 will have both 1) ground water close to the surface which promises to flood more often after trees are removed upstream, and 2) noise levels above 67 decibels, a level deemed unhealthy by a study done around 2005. That study led a previous Council to prohibit building within a specified distance from I-40, well before plans to widen I-40 were announced.

Because we recognize that the Town is now at the final stage of a conditional use application, we recommend the following steps that would mitigate the inevitable stormwater and environmental problems we see inherent in this design.

1. Recommendations to reduce stormwater impacts.

- Reduce disturbance of RCD areas. The proposed plan disrupts the RCD by 40% in some places. (Some of the other requests to remove
- poorly placed units could allow the applicant to make the stormwater basins planned within the RCD smaller, thus disturbing less space in the RCD.) Also ask the applicant to redistribute the load from basins currently inside the RCD to basins outside the RCD.
- b) Ask applicant to use alternatives to placing pervious pavement especially in areas subject to flooding, and that would provide quantifiable improvements in the amount of run-off or move pervious pavement to the southern half of the development where flooding is not an issue and the soil percolates better. (Applicant endeavoring to meet pervious surface requirement calculation.) Adopt a maintenance plan if the pervious pavement remains.
- c) Remove the three townhouse apartments that are now placed on top of an ephemeral stream (previously designated a perennial/intermittent stream.)
- d) Since the existing stream determination has expired, Council could reasonably request a new stream determination in order to decide whether the placement of the units would be within the RCD. Please make that request a part of this conditional use permit. If the determination shows the stream is indeed ephemeral then the building could stay. It intermittent then townhouses need to be pulled back.
 - e) Require a bond for potential failure of stormwater retention basins and failure of pervious pavement to protect the five homes downstream and failure of pervious pavement.

2. Recommendations to mitigate noise.

When DOT builds a noise wall for Chandlers Green there will no longer be any Chapel Hil home suffering from unhealthy levels of noise - until the Habitat homes are built. {See slides in attachment #2 below showing sound effects from I-40.}

- a) Remove from plan the 10 homes now located in the Northeast quadrant that will experience noise above 67 decibels. (This change would also prevent flooding when trees are removed.) These units, if built, would endure terrible noise impacts causing hearing loss and other diseased and heightened particulate matter emissions causing lung and heart disease. {See attachment #2.}
- b) The applicant has suggested that they will build a berm to mitigate the noise. However the proposed berm is too far from the highway and crosses an area that is 12 feet lower than the interstate and we have no proof it will be effective as the developer has refused to supply an engineering standard for noise. We recommend the current Council follow the previous Council's approach of not building within areas exposed to dangerous noise levels. We know I-40 will be widened soon to 6 lanes compounding the noise problem.

e) In addition we request an updated noise study showing whether or not the proposed berm will sufficiently solve the noise problem, and demonstrate that health is no longer a concern.

We regret that the opportunity was missed early in the review to improve stormwater and environmental design and eliminate what will certainly become problems for the future homeowners. In our zeal to help this project succeed by making exceptions to our regulations (significant incursion into the RCD among others), we strongly implore the Town Council to avoid putting future residents in harm's way by approving homes that will flood and houses so close to I-40 they will cause hearing loss in the young and old, as well as a wide range of health conditions. However, it is not too late to consider the recommendations we've put forward which will substantially improve upon the design flaws we've identified.

Finally, as noted above, stormwater and environmental issues continue to be considered well after a design is submitted for a permit. If the Town is to create truly sustainable projects, Chapel Hill must include environmental and stormwater review and board discussions earlier in the planning process. By doing so, the town would greatly improve most of its developments and move us toward our goals adopted in the Paris Accords.

The is the complete text from my presentation last night. Unfortunately, my Internet was going out and I was cut the 1.5 minutes due to earlier speakers going over.

Hello, I am Mike Murphy. Thank you for the opportunity to address the Mayor and Council tonight. I would like to focus specifically on environmental and stormwater concerns.

I am one of the few people that has attended all of the board reviews, public workshops and Town Council hearings.

Tonight, the community will raise some concerns. It is important to understand that these concerns aren't isolated... the review boards raised these same issues.

- 1. Very crowded density
- 2. Very high percentage of hard surface in the building site
- 3. Incursion into the RCD's by stormwater feature
- 4. Removal of a significant number of rare and specimen trees
- 5. Large amounts of difficult-to-maintain pervious pavement
- 6. Dog park and community garden adjacent to a major wetland
- 7. Homes placed too close to I-40
- 8. Homes could not be made "solar-ready"

Still, the boards voted unanimously to approve the project -- not because they felt the issues were **small**, but because they felt the importance of affordable housing was **large**. No one wanted to be responsible for delaying such an important project -- and I also share this sentiment.

To cover all of the environmental and stormwater issues, would take at least 30 minutes, but since I have less than 3 minutes left, I will cover the 3 most important issues -- the issues that could create lingering problems for the residents of Weavers Grove and the neighbors in Chandler's Green.

FIRST, the northeast quadrant of the development presents some unique challenges. Not only is it subjected to excessive highway noise, it is the site of a forested wetland. With the exception of the hottest few weeks in the summer, this area is wet the year round. During major storms the water flows northeast and onto the shoulder of I-40, where it is funneled into the highway's extensive stormwater system.

The problem with building in this saturated area is that when the surrounding forest is cleared, the volume of water will significantly increase and the saturated area will become larger. One of three things will happen, and they are all bad,

- 1. Homes sit in a swamp most of the year
- 2. The developer will drain this swamp onto I-40
- 3. The developer will drain this swamp through the neighbor's properties.

For obvious reasons the developer has chosen the third option. Water is channeled via a very long culvert into the stormwater pond that empties into the stream that sends water into Chandler's Green. The developer is channeling water, that would normally flow north onto the highway, completely across the property to exit in the south. Water from the wettest area of the Weavers Grove development is placed on the adjacent neighbors that are already suffering from drainage and flooding issues. This is *new water* that they never needed to accept before.

SECOND, three Weavers Grove townhouses are being built on top of the southern stream that empties through Chandler's Green properties. This portion of the stream was most recently classified as ephemeral, but that classification has expired. Historically, it has been classified as perennial/intermittent, and our expert claims it is intermittent. Those of you who toured the property remember that this stream was clearly channelized and flowing.

The problem with building over that portion of the stream is that it is lower than any of the detention basins -- any stormwater will enter the stream directly. This is true regardless of the stream classification.

Natural streams exist because of durable geological conditions. Even if the stream is removed by excavation, the underlying geology will attempt to recreate the stream. This will lead to erosion and water damage for the townhouses.

THIRD, the planned placement of the sewer appears to be underneath the wetland and stream that passes between the Chandler's Green properties. This placement runs counter to the Jordan Lake Rules.


Removing trees and dredging across the wetland and stream will increase the problems for these homes. The crooked path of the sewer will require several ugly raised manholes in our neighbor's backyards, and the sewer line will be placed uncomfortably close to one of our neighbor's foundation.

Sadly, these "three most important issues" all affect the same 3 to 5 "already at risk" Chandler's Green homes, and the issues are cumulative. We suggest three fixes.

- 1. Don't clear the far northeastern edge of the Weavers Grove property (this would also address the highway noise concern).
- 2. Remove the three townhouses on top of the southern stream
- 3. Relocate the sewer away from the southern stream

Last night's meeting went into today so I know I am within the 24 hour timeline to submit additional comments.

TWO PARKS FOR THE PRICE OF ONE!!

Instead of using the entire American Legion property to develop a very large park, think about allocating half of it to Habitat to build the Weavers Grove community. This would still leave enough acreage for a large recreational park. In exchange, turn the current Sunrise Road acreage into a second park preserving the natural beauty of the environment.

I'm sure you've already thought of this before but maybe not since so many serious issues have arisen as the process for the Sunrise Road location has evolved – especially since Carol Woods withdrew their support.

The American Legion land --

- 1) requires minimal clearcutting and probably has little to no acreage that is RDC to work around;
- 2) would not have the serious issues of I-40 noise, storm water management, heavy traffic as well as pedestrian/student/bicyclist safety concerns as does the current site;
- 3) would be walkable to Wegman's and presumably already has bus lines to nearby Rams Plaza, Eastgate, and University Place;
- 4) offers easy walkable access to a number of health care centers; and
- 5) would have a city park right next door minimizing the need, and saving some funding, for recreational areas on Sunrise that are woefully inadequate for the number of residents.

The Sunrise Road location --

- 1) could be turned into a park that would preserve, respect, and honor the natural environment and beauty of the wetlands, marshes, wildlife, etc.
- 2) would have enough space for parking, pedestrian and bicycle paths, and benches without clearcutting and disturbing the RDC acreage

I know you're shaking your heads and thinking you shouldn't go back to the constituents who were involved in the decision to develop a park on the American Legion site. However, given the easy passage of the Affordable Housing Bond, and the advantage of having two parks with different character but essentially the same acreage, would be inviting, in addition to offering a vastly better and safer location for the residents of Weavers Grove.

Hello, I am Mike Murphy. Thank you for the opportunity to address the Mayor and Council tonight. I would like to focus specifically on environmental and stormwater concerns.

I am one of the few people that has attended all of the board reviews, public workshops and Town Council hearings.

Tonight, the community will raise some concerns. It is important to understand that these concerns aren't isolated... the review boards raised these same issues.

- 1. Very crowded density
- 2. Very high percentage of hard surface in the building site
- 3. Incursion into the RCD's by stormwater feature
- 4. Removal of a significant number of rare and specimen trees
- 5. Large amounts of difficult-to-maintain pervious pavement
- 6. Dog park and community garden adjacent to a major wetland
- 7. Homes placed too close to I-40
- 8. Homes could not be made "solar-ready"

Still, the boards voted unanimously to approve the project -- not because they felt the issues were **small**, but because they felt the importance of affordable housing was **large**. No one wanted to be responsible for delaying such an important project -- and I also share this sentiment.

To cover all of the environmental and stormwater issues, would take at least 30 minutes, but since I have less than 3 minutes left, I will cover the 3 most important issues -- the issues that could create lingering problems for the residents of Weavers Grove and the neighbors in Chandler's Green.

FIRST, the northeast quadrant of the development presents some unique challenges. Not only is it subjected to excessive highway noise, it is the site of a forested wetland. With the exception of the hottest few weeks in the summer, this area is wet the year round. During major storms the water flows northeast and onto the shoulder of I-40, where it is funneled into the highway's extensive stormwater system.

The problem with building in this saturated area is that when the surrounding forest is cleared, the volume of water will significantly increase and the saturated area will become larger. One of three things will happen, and they are all bad,

- 1. Homes sit in a swamp most of the year
- 2. The developer will drain this swamp onto I-40
- 3. The developer will drain this swamp through the neighbor's properties.

For obvious reasons the developer has chosen the third option. Water is channeled via a very long culvert into the stormwater pond that empties into the stream that sends water into Chandler's Green. The developer is channeling water, that would normally flow north onto the highway, completely across the property to exit in the south. Water from the wettest area of the Weavers Grove development is placed on the adjacent neighbors that are already suffering from drainage and flooding issues. This is *new water* that they never needed to accept before.

SECOND, three Weavers Grove townhouses are being built on top of the southern stream that empties through Chandler's Green properties. This portion of the stream was most recently classified as ephemeral, but that classification has expired. Historically, it has been classified as perennial/intermittent, and our expert claims it is intermittent. Those of you who toured the property remember that this stream was clearly channelized and flowing.

The problem with building over that portion of the stream is that it is lower than any of the detention basins -- any stormwater will enter the stream directly. This is true regardless of the stream classification.

Natural streams exist because of durable geological conditions. Even if the stream is removed by excavation, the underlying geology will attempt to recreate the stream. This will lead to erosion and water damage for the townhouses.

THIRD, the planned placement of the sewer appears to be underneath the wetland and stream that passes between the Chandler's Green properties. This placement runs counter to the Jordan Lake Rules.


Removing trees and dredging across the wetland and stream will increase the problems for these homes. The crooked path of the sewer will require several ugly raised manholes in our neighbor's backyards, and the sewer line will be placed uncomfortably close to one of our neighbor's foundation.

Sadly, these "three most important issues" all affect the same 3 to 5 "already at risk" Chandler's Green homes, and the issues are cumulative. We suggest three fixes.

- 1. Don't clear the far northeastern edge of the Weavers Grove property (this would also address the highway noise concern).
- 2. Remove the three townhouses on top of the southern stream
- 3. Relocate the sewer away from the southern stream

CHALT strongly supports the provision of a wide mix of affordable housing types in Chapel Hill, especially housing for those with the greatest need and fewest resources. We admire the model pioneered by Habitat for Humanity that employs the labor of future homeowners, as well as that of volunteers, to build houses for people for whom home ownership would otherwise be difficult or impossible. The creation of 100 new affordable units at Weaver's Grove will be a significant benefit to the units' future owners and to the community as a whole and will be an even greater benefit if these new homes are located on desirable lots, with appropriate noise control.

Weavers Grove presents unique challenges which have not yet been addressed, but we feel these challenges can be overcome with certain design modifications.

Specifically, this proposal is environmentally and economically unjust because it places the affordable homes on the least desirable parts of the property where future residents are sure to encounter problems because:

- The least desirable places to build are located north of the power line wetlands and RCD in the northwest and pooled standing water in the presently forest northeast quadrant - where the affordable Habitat homes are to be placed.
- Much of the site is covered with power lines, streams and wetlands.
- This northeast area also borders an elevated section of I-40 that is soon to be widened to 6 lanes, which will exacerbate the area's already significant noise and air pollution. https://publicinput.com/l-40-Orange-County
- The limited buildable area of the site is almost entirely covered with a "hard surface" -- streets, parking lots and roofs, which will exacerbate stormwater runoff and contribute to flooding.

Recent advisory board reviews have produced many comments about the density of the plan that will greatly reduce tree cover and increase the chance of stormwater problems. We share these concerns. But, unfortunately these Board reviews come at the end of the development review cycle instead at the start of the review process, when there is little opportunity to remedy obvious problems without requiring a disruptive redesign. For example, the Stormwater Advisory Board discussed at length the concern about the requested RCD exceptions, yet failed to weigh in with a recommendation that might jeopardize the project as it neared the final stage. The Stormwater Board will take up the issue of early review at their next meeting. Further, the Town stormwater staff chose not to enter expert opinion and the neighborhood spokesman had a family emergency so relevant information was withheld from consideration.

Stormwater and environmental issues continue to be considered well after a design is submitted for a permit instead of at the start of the process. Chapel Hill must find a way to include environmental and stormwater discussions earlier in the planning process, if the Town is to create truly sustainable projects. An early review would have prevented the following serious site design problems:

- Stormwater features are located outside of the buildable area and some of the larger stormwater retention basins are placed right in the Resource Conservation District (RCD). The RCD was intended to remain undisturbed in order to function as an additional protection for water quality as well as for ecological conservation and a wildlife corridor. Allowing abundant exceptions undercuts the usefulness of having such an ordinance.
- Stormwater is transported long distances in underground culverts. The stormwater retention design
 does not follow the natural slope and drainage plains of the property. Piping storm water long
 distances repeats the failed Eastgate design of stormwater management. Our Stormwater Board seeks
 daylighting solutions for stormwater. The Chapel Hill-Carrboro Schools administration sought early
 stormwater input which enabled the use of some of these solutions.
- Pervious pavement is used to meet stormwater requirements but we question that it can be properly
 maintained by the Homeowners Association. Most of the "green space" and walking trails are placed
 outside the buildable area, which is dominated by parking lots and immature trees. This contributes to a
 "heat island" effect and a more bleak environment than if the green space and water features had been
 integrated amongst the building units. {See attachment #2 example of high density 751 project.}
- Instead of making use of the natural features, the entire site will be re-graded. Most of the Specimen and Rare trees are removed. There are at least 5 clusters of valuable hardwood on this site. Three of them will be removed if the Town Manager grants an exception to our Canopy Tree Ordinance.)
- The buildings are not oriented to allow solar panel installation. This suggestion was discussed by the Environmental Stewardship Board, but ultimately the Board majority did not want to impede the project or call for a redesign at this late stage even though they liked the idea. These homes will thus depend on ever more expensive electrical power.
- Three townhomes are placed on top of a stream that is now ephemeral but once was considered perennial. A new stream designation would be timely.
- Ten of the homes placed very close to I-40 will have both 1) ground water close to the surface which promises to flood more often after trees are removed upstream, and 2) noise levels above 67 decibels, a level deemed unhealthy by a study done around 2005. That study led a previous Council to prohibit building within a specified distance from I-40, well before plans to widen I-40 were announced.

Because we recognize that the Town is now at the final stage of a conditional use application, we recommend the following steps that would mitigate the inevitable stormwater and environmental problems we see inherent in this design.

1. Recommendations to reduce stormwater impacts.

- a) Reduce disturbance of RCD areas. The proposed plan disrupts the RCD by 40% in some places. (Some of the other requests to remove
- poorly placed units could allow the applicant to make the stormwater basins planned within the RCD smaller, thus disturbing less space in the RCD.) Also ask the applicant to redistribute the load from basins currently inside the RCD to basins outside the RCD.
- b) Ask applicant to use alternatives to placing pervious pavement especially in areas subject to flooding, and that would provide quantifiable improvements in the amount of run-off or move pervious pavement to the southern half of the development where flooding is not an issue and the soil percolates better. (Applicant endeavoring to meet pervious surface requirement calculation.) Adopt a maintenance plan if the pervious pavement remains.
- c) Remove the three townhouse apartments that are now placed on top of an ephemeral stream (previously designated a perennial/intermittent stream.)
- d) Since the existing stream determination has expired, Council could reasonably request a new stream determination in order to decide whether the placement of the units would be within the RCD. Please make that request a part of this conditional use permit. If the determination shows the stream is indeed ephemeral then the building could stay. It intermittent then townhouses need to be pulled back.
 - e) Require a bond for potential failure of stormwater retention basins and failure of pervious pavement to protect the five homes downstream and failure of pervious pavement.

2. Recommendations to mitigate noise.

When DOT builds a noise wall for Chandlers Green there will no longer be any Chapel Hil home suffering from unhealthy levels of noise - until the Habitat homes are built. {See slides in attachment #2 below showing sound effects from I-40.}

- a) Remove from plan the 10 homes now located in the Northeast quadrant that will experience noise above 67 decibels. (This change would also prevent flooding when trees are removed.) These units, if built, would endure terrible noise impacts causing hearing loss and other diseased and heightened particulate matter emissions causing lung and heart disease. {See attachment #2.}
- b) The applicant has suggested that they will build a berm to mitigate the noise. However the proposed berm is too far from the highway and crosses an area that is 12 feet lower than the interstate and we have no proof it will be effective as the developer has refused to supply an engineering standard for noise. We recommend the current Council follow the previous Council's approach of not building within areas exposed to dangerous noise levels. We know I-40 will be widened soon to 6 lanes compounding the noise problem.

e) In addition we request an updated noise study showing whether or not the proposed berm will sufficiently solve the noise problem, and demonstrate that health is no longer a concern.

We regret that the opportunity was missed early in the review to improve stormwater and environmental design and eliminate what will certainly become problems for the future homeowners. In our zeal to help this project succeed by making exceptions to our regulations (significant incursion into the RCD among others), we strongly implore the Town Council to avoid putting future residents in harm's way by approving homes that will flood and houses so close to I-40 they will cause hearing loss in the young and old, as well as a wide range of health conditions. However, it is not too late to consider the recommendations we've put forward which will substantially improve upon the design flaws we've identified.

Finally, as noted above, stormwater and environmental issues continue to be considered well after a design is submitted for a permit. If the Town is to create truly sustainable projects, Chapel Hill must include environmental and stormwater review and board discussions earlier in the planning process. By doing so, the town would greatly improve most of its developments and move us toward our goals adopted in the Paris Accords.

Chandler's Green Homeowners' Association Response to Public Hearing of June 10, 2020 Weavers Grove Development Rezoning

June 11, 2020

The Chandler's Green Homeowners Association (HOA) would like to see the Weavers Grove development succeed in achieving its vision of a mixed income development offering affordable housing and market rate homes adjacent to our community. We still have three primary concerns we feel are critical to the health and welfare of our residents which as yet have not been adequately addressed by the applicant or the town.

Executive Summary:

1)Amesbury Connection - critical concern

Require Amesbury to be clearly defined as emergency access only as previously agreed upon by Weavers Grove and Chandlers Green. Alternatives could include some combination of:

- 1. Removable bollards, gates, or floppy paddles.
- 2. Distinct pavement, such as pervious pavers
- 3. Emergency Access Only signs
- 4. Traffic calming, such as planters, speed tables, humps, or bumps

2) Sound and Particulate Pollution: critical concern

Require that Weavers Grove and Chandler's Green residents are able to enjoy neighborhoods that are safe from the scientifically proven health risks due to unsafe noise levels by:

- 1. Requiring the developer to conduct a new, expert sound study in coordination with the NC DOT, projected out to include the widening of I-40 and standard projections of traffic growth.
- 2. Gaining assurances that no homeowner on the property will be exposed to unsafe noise levels greater than 67dB, the NC DOT noise standard (eg., not clear beyond the 67dB level).
- 3. Gaining assurances from the developer that the Weavers Grove development will not impose noise levels that exceed current unhealthy levels to the homeowners of Chandlers Green as a result of their land clearing and/or berm construction.
- 4. Once these assurances are provided, hold the developer accountable to achieve those assurances.
- 5. Coordinate with NCDOT on the design and construction of any noise abatement tactic now to avoid the creation of noise channels into Chandler's Green between Weavers Grove berms and future NC DOT sound walls.

3) Storm water, drainage, and flooding risks for Chandler's Green Properties along the Southern Stream: critical concern

Protect the Weavers Grove residents and the Chandler's Green neighbors from drainage and flooding issues:

- 1. Update the stream classification on the southern stream which has expired.
- 2. Request the developer work with OWASA to come up with a plan for a sewer line that does not cross the wetlands or pass beneath the stream on the Chandler's Green property (minimizes the effect on any RCD and complies with Jordan Lake Rules).
- 3. Require the developer to provide assurances that the storm water system and pervious pavement will be properly maintained for perpetuity.

Analysis and Recommendations:

1) Amesbury Connection: critical concern

Issue:

Traffic will naturally move to the least congested path. If the net street width for New Ginger Road (with parking subtracted) is narrower than Sweeten Creek Road, there will be an incentive to enter Chandler's Green and exit through Sweeten Creek Road. Diverting traffic that would otherwise exit on New Ginger Road onto Sweeten Creek Road is an unnecessary health and safety hazard for Chandler's Green residents. Weavers Grove will produce on average, 2,300 trips per day. Most of these trips will take place through Amesbury. This is more than double the trips of Chandlers Green.

Background:

Through previous application cycles everyone (the CDC, The Planning Commission, the Town Council, the developer, and Chandler's Green) agreed that creating identical width of streets leading to the entrances to each neighborhood would ensure that neither neighborhood would be burdened with bypass traffic from the other neighborhood. If one neighborhood had a wider path with fewer traffic calming features, then the traffic from both neighborhoods might prefer this path.

Chandler's Green uses Sweeten Creek Road from Amesbury to Sunrise Road. The road is a 60 ft wide Right of Way, with 30 ft paved (curb to curb). No parking is allowed on the street during weekdays. The current proposed plan for New Ginger Road is for 29 ft (curb to curb) with an 8 ft wide parking lane subtracted from the net width, leaving only 20 ft for constrained two-way traffic. With intended traffic from City buses, school buses, garbage/recycle trucks, delivery vehicles and service vehicles, two-way, simultaneous traffic will not be possible. Weavers Grove traffic will have significant incentive to divert through Chandler's Green, where the roads are fully 50% wider and there is free movement of two-way traffic.

Require Amesbury to be clearly defined as emergency access only as previously agreed upon by Weavers Grove and Chandlers Green. Alternatives could include some combination of:

- 1. Removable bollards, gates, or floppy paddles.
- 2. Distinct pavement, such as pervious pavers
- 3. Emergency Access Only signs
- 4. Traffic calming, such as planters, speed tables, humps, or bumps

2) Sound and Particulate Pollution: critical concern

Issue:

Sound and particulate pollution from I-40 is a very serious health hazard to the residents of both Weavers Grove and Chandler's Green. The current proposal for Weavers Grove removes the 67 dB line and places affordable housing units in areas with noise levels above 70dB.

Background:

Experts disagree on the extent to which trees buffer sound, but the consensus is that they do provide some value. Removing trees and adding hard pavement, basketball courts and buildings will absolutely increase the sound levels. Removing the tree canopy to make way for this development is going to exacerbate this problem.

Developers and towns today have the benefit of research which unequivocally proves that exposure to <u>sustained noise beyond certain decibel levels</u>, and high levels of <u>fine particulate matter</u>, are harmful to health. Much like second-hand smoke years ago, we now have to worry about these two risk factors as they're now understood to cause things like arterial hypertension, myocardial infarction, stroke, hearing impairment, lung cancer and cardiopulmonary mortality and more.



NCDOT considers traffic noise levels in excess of 67 dB to be dangerous (<u>NC DOT 201 Noise Manual</u>); HUD considers noise levels above 65 dB "normally unacceptable" (<u>HUD Noise Abatement and Control</u>); The World Health Organization considers average traffic noise above 53 dB to be unhealthy (<u>Environmental Noise Guidelines for the European Region</u>). <u>EPA</u> and <u>WHO</u> also have published their standards. The noise levels that Weavers Grove residents will be exposed to will exceed all of these research-based noise standards for residential land use.

Combustion-related fine particulate matter pollution is associated with cardiopulmonary and lung cancer mortality when there is long term exposure (<u>JAMA. 2002 Mar 6;287 (9):1132-41</u>), and its concentration drops rapidly with distance. The combination of noise and fine particulate matter have been shown to have negative effects on health for people of all ages, summarized in part of this <u>USC Infographic</u>.

Chapel Hill, which boasts a large number of PhDs among its residents, has not as yet incorporated this scientific evidence into responsible policies for land use. NC DOT encourages municipalities to take this step and the NC Legislature has cleared legislative obstacles to do that.

Some communities have already adopted Noise Compatible Planning, whereby noise levels are among their criteria for approving land use proposals and development plans. These communities recognize the value of placing residential developments in zones where their health is among their primary goals.

Take <u>San Jose</u> for example, which considers noise levels exceeding 75 dB unacceptable for residential developments under any circumstances, and levels between 60 and 75dB to be conditionally acceptable., where the developer is required to undertake remediation steps. Furthermore, for new residential developments near freeways, air quality modeling is required as well as implementation of mitigation measures, such as moving further from the source, to minimize exposure to these toxins.

Even the real estate industry appreciates the importance of noise in their market and now promotes a service on the Realtor.com website and apps that allows homebuyers to check on environmental noise surrounding their prospective homesite.

Many of the Chandler's Green homes directly adjacent to Weavers Grove already have noise levels between 60 dB and 75 dB. The proposed Weavers Grove units placed between the power-lines and I-40 range between 55 dB and 78 dB. This issue had been discussed at length during previous application cycles over the past 17 years. Both the developer and Chandler's Green have hired separate acoustic experts to analyze the problem and propose solutions.

Once again, everyone agreed on a simple solution. It was to limit any clearing to a measured 67 dB buffer line. The current proposal for Weavers Grove removes the 67 dB line and places units in areas with noise levels above 70 dB.



A further concern is that when I-40 is widened, the NC DOT predicts that the decibel levels will increase on the Weavers Grove site by an estimated 4 dB. This increase will not be abated by efforts from any NC DOT sound walls, since the permitting for buildings on the Weavers Grove property will not have been issued in time for the Date of Public Knowledge of the widening project (March 29, 2019). To mitigate that additional 4 dB, this 67 dB line would have to be placed over 230 feet further into the development from its current location, illustrated to the left. As you can see, this shows that a significant number of the affordable homes as well as some market rate dwellings would be sitting in unhealthy zones once I-40 is widened.

Although HHOC recognized these risks in

2008, this seems to no longer be the case. In its LUPA analysis dated June 10, 2020, the Town staff also appears willing to overlook the health of the residents of Weavers Grove.

Alternative noise abatement solutions, such as sound walls and berms have been considered. The conclusion is that they will not be effective, because:

1. The abatement solution will be located too far from both the source and the receiver to create any significant insertion loss.

- 2. The terrain is unsuitable to sound walls and berms, because it crosses a deep depression formed from the natural drainage channel and the bed from an old pond, which is 15 ft below the highway and significantly lower than the planned buildings. (The drainage channel and associated wetlands also present environmental placement and maintenance challenges for walls and berms.)
- 3. The length of any berm or wall is constrained on one side by the Chandler's Green properties and on the other side by wetlands and streams. (Design guidelines require that the length of the sides need to extend an additional 4X the length of the setback from the source, in order to be effective.)
- 4. Once the highway widening occurs, NC DOT will place sound walls within the highway buffer along sections of Chandler's Green homes that are also predicted to experience a noticeable increase in sound due to the widening. Since there will be no sound wall provided by NC DOT along Weavers Grove, the Weavers Grove sound berm needs to be properly engineered and aligned with the adjacent DOT sound walls alongside Chandler's Green to avoid creating an even more significant noise risk to Weavers Grove residents as well as to adjacent Chandler's Green residents.

If all of these issues with the intended berm were resolved, the developer must assure the town that the noise abatement plan will achieve a specific noise standard no greater than 67dB, and be held accountable to achieve those standards. Residents of Weavers Grove and Chandler's Green deserve to live in safe communities, not exposing them to known health risks.

There are alternative site designs to deal with these risks. For example, they could include the removal of the unsafe homes from the plan, or relocate them to a safer location; decide to not clear beyond a 67dB line and place all of the homes in healthy zones of the property; relocate the affordable homes to higher, dryer ground closer to Sunrise and Ginger Road, and partner with a private developer to invest private funds in the sound abatement requirements for its market rate homes nearer the Interstate.

In an effort to achieve the much needed affordable housing in Chapel Hill, the Town Council is asked to take science into consideration, take the necessary time to consider the health risks that are associated with this plan, and insist that a successful development does not put the health of its residents at risk.

Require that Weavers Grove and Chandler's Green residents are able to enjoy neighborhoods that are safe from the scientifically proven health risks due to unsafe noise levels by:

- 1. Requiring the developer to conduct a new, expert sound study in coordination with the NC DOT, projected out to include the widening of I-40 and standard projections of traffic growth
- 2. Gaining assurances that no homeowner on the property will be exposed to unsafe noise levels greater than 67dB, the NC DOT noise standard (eg., not clear beyond the 67dB level).
- 3. Gaining assurances from the developer that the Weavers Grove development will not impose noise levels that exceed current unhealthy levels to the homeowners of Chandlers Green as a result of their land clearing and/or berm construction.
- 4. Once these assurances are provided, hold the developer accountable to achieve those assurances.
- 5. Coordinate with NCDOT on the design and construction of any noise abatement tactic now to avoid the creation of noise channels into Chandler's Green between Weavers Grove berms and future NC DOT sound walls.

3) Storm water, drainage, and flooding risks for Chandler's Green Properties along the Southern Stream: critical concern

Issue:

About half of the storm water and all of the waste water is expected to be removed across our properties. Several of our properties along the path of the water already have severe drainage issues and occasional flooding problems that endanger the habitability of the homes. The addition of a sewer main through the wetlands and beneath streambed will create additional risks to our homeowners.

Background: T

he Weavers Grove property is "water locked." About half of the water flows north and exits through a very small (48 inch circular) culvert under I-40. The other half of the water exits through a stream across two of the Chandler's Green properties. The water then passes underneath Sweeten Creek Road and flows in a stream between our common area playground and several more of our homes. The Southern stream eventually meets up with the Northern Stream in the Springcrest neighborhood.


I-40 marks the northern edge of the Urban Services Boundary. There is no ability to pass any waste water under I-40, and so all of the waste water either needs to pass across the Chandler's Green properties or needs to be pumped out. The original plan between Habitat and OWASA was to pump the waste water out to Sunrise Road. This was the expectation that the Chandler's Green HOA had until the sewer lines surfaced in a drawing for the Habitat/Carol Woods project.

A commercial developer, Gary Wallace, had previously planned to develop the 7-acre Potted Plant property as a separate subdivision (completely unrelated to any planned Habitat development). In 2006, Mr. Wallace approached two of our neighbors to provide a small sewer lateral to connect a few remote houses on this 7-acre parcel. The two neighbors were told that they would each be paid \$2,000 as compensation. The consideration was never given, and unbeknownst to them the easement document they were given to sign was for a large sewer main with potentially visible raised manholes, NOT a small invisible sewer lateral. It was not until 2019 when they discovered they had been defrauded into signing a document that was different than they had intended.

All of our Chandler's Green properties are covered by a set of restrictive covenants that require HOA approval prior to the construction of any structures. No request has been made for approval of any sewer structure.

As the stream approaches the Chandler's Green properties it passes through a designated riverine wetland. The wetland area has a very high water table, as do the five adjoining Chandler's Green properties. These five homes surrounding where the stream exits all have drainage issues. Some homes have required the installation of sump pumps in the crawl space to evacuate rising water during wet periods. During major storms, flooding occurs. Occasionally, the culvert under Sweeten Creek Road reaches its capacity, and the stream between two Chandler's Green homes begins to rise rapidly.

During the 17-year course that this project has been contemplated, the Southern fork of Dry Creek has been classified several times. Each time it had been classified as a stream with an intermittent portion at the beginning near the Duke Power Tower followed by a perennial portion as it moved closer to the Chandler's Green properties. In 2015, the stream was reclassified, and this time the results were completely different. Even though 2015 was a 4 relatively wet year, the entire stream was downgraded. The previous intermittent portion became ephemeral, and the previous perennial portion became intermittent. The exact same person made the last two classifications. The experts we consulted could offer us no explanation except that it was obviously mis-classified.



The current storm water design places the detention basin on the slope above the stream, right above the wetlands. With this design, all of the upstream storm water needs to be captured by grates and channeled around the mis-classified stream to the remote basin. Given the serious issues we already have with drainage and flooding, this is probably the worst possible design they could have come up with. A BMP design would place the detention basin far closer to the upstream sources of the storm water. The Habitat design has no safety factors built in. Due to this faulty design, failures will be consequential for Chandler's Green properties.

Protect the Weavers Grove residents and the Chandler's Green neighbors from drainage and flooding issues:

- 1. Update the stream classification on the southern stream which has expired.
- 2. Request the developer work with OWASA to come up with a plan for a sewer line that does not cross the wetlands or pass beneath the stream on the Chandler's Green property (minimizes the effect on any RCD and complies with Jordan Lake Rules).
- 3. Require the developer to provide assurances that the storm water system and pervious pavement will be properly maintained for perpetuity.

Dear Mayor Hemminger, Town Council Members and Town Manager Jones,

Ref.: Re-zone R2-R6 Of 7516 Sunrise Road. (Weaver's Grove)

Since 1991, we have lived in the neighboring community to 7516 Sunrise called Chandler's Green.

We do support the intended Affordable Housing initiative (e.g., Habitat).

However, there are several key issues which we strongly urge the Town Council to objectively review. They are as follows:

- 1. Severe storm water drainage issues compounding already very significant a poor drainage situation sometimes flooding/damaging some homes in Chandler's Green. The current "high density plan" requiring clear-cutting the current wooded area will exacerbate this significant issue. What is the alternative plan to fully avoid massive tree-clearing? We cannot support this as it stands.
- 2. The planned expansion of I-40, the planned massive tree removal, and replacement with impervious pavement will expose far greater noise levels to Weavers Grove residents and Chandler's Green. I understand the current proposal for Weaver's Grove will remove an assumed 67 dB "buffer line". This will place Weaver's units in areas with noise levels *above* 70 dB. NCDOT considers noise above 65 dB *to be dangerous*. The NCDOT 40 expansion will raise the noise level by 10% (77dB) as we understand it. We cannot support this plan as it stands.
- 3. **An order of magnitude increase in traffic.** It is estimated that we will probably see an increase of 500 cars. The current plan is to probably open Amesbury in Chandler's Green. Residents will take this "short cut," increasing *risk to pedestrian and children's safety*. We cannot support this as it stands. Moreover, what is the plan to support mass transit to adequately support those living in affordable housing who may not have cars?

In summary, we believe that Chapel Hill has in effect, "run out of affordable land to build affordable housing". Support for true affordable housing is a goal for us all. But this evident shortage is not a justification to then build extremely high density building on land which clearly cannot sustain such. The current plan will fail the future inhabitants of Weaver's Grove and Chandler's Green residents. Previous plans over the last 15 or so years all have reflected reduced number of 'homes' to balance-out and/or avoid the above cited "environmental" issues. I understand only 99 of the 243 units (40%) are for affordable housing. Why not target 100-110 units for affordable housing (i.e., addressing all the above issues) and stop at this level so as to not totally rely on "market-based units" to financially justify/subsidize the total project? The number of additional market-based homes are the root cause of these negative issues. If this alternative approach increases costs to require more bond funding, so be it. We would support this path 100%. As it is now, we do not support the current project.

We urge the Chapel Hill Town Council to carefully review in detail and reconsider the entire premise and key assumptions of the current plan. The above cited concerns must be fully addressed and projected negative impacts fully eliminated.
