WHEREAS, Karen Stegman has served the Town of Chapel Hill as Town Council Member since December 6, 2017; and

WHEREAS, Karen brought to the Council a wealth of experience and expertise in social justice, coupled with a steadfast commitment to implementing innovative solutions to the challenges facing Chapel Hill; and

WHEREAS, Karen served as Mayor Pro Tem from 2021 to 2023; and
