Green, seconded by Zibaie, moved to recommend approval of Resolution A. The motion passed on a 5-0 vote.

Zibaie moved to recommend Ordinance A, but the motion did not receive a second.

Mills, seconded by Losos, moves to recommend Ordinance A with the modification that the developer provide a minimum of 30 affordable units in the development's Affordable Housing Plan and a voluntary contribution of \$1 million to the Town's Affordable Housing Funding Program. The motion failed in a 2-3 vote (Mills and Losos in favor, Mitchell, Green, and Zibaie against).

Mitchell, seconded by Losos, moves for the Planning Commission to transmit comments without a recommendation to convey the Planning Commission's comments on the application to the Town Council.

- Planning Commission is sensitive to the financing challenges of the project and that the payment may be helpful to the applicant.
- Council should hear from the Affordable Housing staff about if staff believes the modification is beneficial to the Town's affordable

housing goals and why.

- Planning Commission believes that in general, on-site units are more valuable than a payment and the Town should try to secure as many units as possible that can be inhabited in the near-term.
