A motion was made by Miller, seconded by McAvoy-Bickford to end questioning and begin deliberations. The motion carried by a unanimous vote.

Following deliberations among the Board, a motion was made by Wortman, seconded by Strada, to close the evidentiary hearing. The motion carried by a unanimous vote.

A motion was made by Strada, seconded by Miller, to approve Resolution A, which directed staff to draft an order APPROVING the requested variance. The motion carried by a unanimous vote.

- 3) recommend that the Town Council allow the Board of Adjustment to operate with eight members until such time as it has seven members.
