2025-2026 Community Development Block Grant Annual Action Plan and 2025-2029 5-Year Consolidated Plan

Town Council held an initial public forum on November 13, 2024 and will hold a second public forum to review program performance and receive resident input on the draft 2025-2026 CDBG funding plan, Annual Action Plan, 2025-2029 5-Year Consolidated Plan and the draft amended 2020-2021, 2023-2024, and 2024-2025 Annual Action Plans during the Town Council meeting at 6:00 pm on Wednesday, April 9, 2025.

The Action Plan and funding plan decide how the Town will spend federal CDBG money for the next year, and the Consolidated Plan determines Town and Orange County priority areas for federal community development funding over the next five years.

The public is also invited to review and comment on the 2025-2026 Community Development Block Grant (CDBG) funding plan, the draft 2025-2026 CDBG Annual Action Plan, 2025-2029 5-Year Consolidated Plan, and the prior amended Annual Action Plans which will be made available during normal business hours of operation for a period of thirty (30) days beginning Tuesday, April 1, 2025, at the following locations:
