# Dear Mayor and Council members,

As a resident of and homeowner in the Heritage Hills neighborhood, I have followed with interest the hearings and discussion around the redevelopment of the Refuel property at Starpoint, on 15-501 South. I was

dismayed to see in the most recent reporting that apparently inclusion of pedestrian and bicyclist access is still under debate. To Council member Michael Parker, I would say that there are a *surprising* number of pedestrians on Smith Level Road trying to access the Refuel convenience store and Walmart given how unsafe it is to walk or bike along there. If the road is unsafe for pedestrians and cyclists, you are unlikely to see many of them. The time you are looking also makes a difference. Before COVID, I would have agreed that there really didn't seem to be much demand for walking to Starpoint. Now that I work mostly from home and come and go from the neighborhood at different times, I see far more people, often children and adolescents, making that walk. There are also people who walk and cycle that road to get to work at Walmart or further out 15-501 South. It is egregious that our roadways are so unwelcoming to those who are either unable to drive or do not wish to add to the impact of motor vehicles on our environment.

Conscious effort must be made to change the status quo. Chapel Hill has generally been a leader in accessible alternative transportation. Please do not let us down by assuming there is no need for or interest in pedestrian and bicyclist access to the Starpoint area businesses. The Refuel redevelopment is an opportunity to make improvements and provide a safer environment for our residents.

I live in the Heritage Hills neighborhood that will be directly affected by this development project. I'd like to voice my opinion on three aspects:

1. Storm Water run off: Even the present development does not handle storm water sufficiently for large rain events. Not only do ditches overflow onto Smith Level Road but the creek behind my home fills up to dangerously high levels and makes it difficult for utility company vehicles to access problems like a downed line for the homes down

stream. Having more hard surface with the new development will only increase the problem. I urge you to make the developer get this part of the project right.

- 2. Sidewalks and Walkability: I actually walk occasionally to the WalMart on Hwys. 15-501. I especially do this when there is a weather event that causes a utility outage so maybe 4 times a year. I have noticed I'm not the only one that makes the trek. If there were a few retail outlets in the Refuel development, I might walk even more.
- 3. Public Transportation: The elderly in the community have trouble aging in place because there is no access to Easy Rider for transportation to the doctor's office, etc. If you don't give us sidewalks so we can walk to WalMart, it would be nice if some public transportation could extend their reach to include the Heritage Hills neighborhood.
