The Chapel Hill Transportation and Connectivity Advisory Board (TCAB) asks the Chapel Hill Town Council to issue a statement of support for the following letter that TCAB is forwarding to GoTriangle:

The Chapel Hill Transportation and Connectivity Advisory Board is concerned that decisions around rerouting the GoTriangle CRX route, particularly the Chapel Hill portion of the route, appear to have been made in the Wake County Bus Plan without soliciting public input from residents of Chapel Hill. The input was also conducted while the route was out of service, limiting comment opportunities for riders of the CRX route. Major changes were also made to the DRX route in the Wake County Bus Plan.

The Chapel Hill Transportation and Connectivity Advisory Board requests that GoTriangle delay final decisions around changes to bus routes and stops in other Counties and indicate that those routes are pending final review in the bus plans for Orange and Durham Counties.
