Dear Mayor and Town Council,

This Wednesday, Sept. 29, you have the opportunity to adopt a Vision Zero plan for the town of Chapel Hill. I am writing to encourage you to do so, and to commit town resources, including financial resources, to making our community safer for pedestrians, bicyclists, and drivers.

I have reviewed the report prepared for Wednesday's meeting, which effectively summarizes the data on crashes in town, and makes concrete recommendations for how we can make our streets safer. I want to emphasize three points:

1. People will not walk and bike if they perceive that it's unsafe.

There is a growing consensus among the Town Council that we need to make it easier for people to get around our community without relying on a car. While I strongly support expanding our sidewalk network, building greenways and protected bike lanes, and improving our bus service, all of that effort will be for naught if our streets are not safe.

Vision Zero helps underscore the need to make all of our streets safe for all users. What good is a bike path if you have to cross a busy and dangerous street to get to your destination?

2. Chapel Hill should make its own streets safer, and work with NCDOT to make their streets safer.

As the report shows, the most dangerous streets in Chapel Hill are owned and maintained by the NCDOT. The easy thing to do would be to throw up our hands and hope that NCDOT will one day take safety seriously. But if we do that, we'll consign another generation of Chapel Hill residents to living in a community with unsafe streets.

Instead, we should prioritize making our streets safer, particularly those that are already identified in the report as high-crash streets. For example, Cameron Avenue and Country Club Road would be ideal for upgraded safety features, such as protected bike lanes and wider sidewalks, and could be connected to other town-owned streets, like Hillsborough Street, which connects to the Bolin Creek Greenway.

At the same time, we can work with NCDOT on making their streets safer. We need dedicated resources, including an annual financial commitment, to do both.

3. People's lives are at stake. We can do better.

Last year a 15-year-old boy, Chan Mee Ya, was hit by a car on Homestead Road while he was riding his bicycle. Our community came together to raise at least \$100,000 to aid in his recovery, a sign of the wealth and generosity of the people of Chapel Hill.

And yet, the intersection where the crash occurred is just as dangerous as it was the day he was hit. If we treated street safety as seriously as we do airplane safety, there would have been an extensive investigation, and a commitment to improving things on the ground. We could have set up Jersey barriers to create a temporary bike lane while we were studying a longer term solution. We could have installed an in-street sign warning drivers to watch for pedestrians and cyclists. We could have looked into strategies to slow traffic on the street.

Instead, we did nothing. If the Council adopts Vision Zero, and puts real resources into achieving our goals, I hope that we can do better in the future.

Hi Bergen,

I wanted to pass along one data point in case it's useful as the town considers adopting Vision Zero. My husband has a disability that prevents him from gripping with one hand. We had a bike modified for him to have both brakes controlled by one hand. However, he is no longer willing to bike in town because of how poorly bike infrastructure is connected and maintained. Specifically, the bike lane on Cameron is often filled with debris and the pavement is uneven (I assume due to tree roots). He is simply not certain that he can maintain control of a bike in that and other bike lanes.

The effect of this is that when we go downtown, which is nearly every weekend, we are in a car rather than on bikes. That's frustrating to both of us, especially coming here from DC, which had great infrastructure for cyclists and pedestrians.

If we want people to walk and bike (and for resident health, air quality and town vibrance, we need to) we must protect our bikers and pedestrians. We must back up our values and our priorities with action and resources.
