**Subject:** Council Question: Item 2: Friday Center Drive project

**Council Question:** Why is the Town paying so much for a UNC project. Is the Friday Center Drive considered a UNC road/entrance way or is it a Town Road and why are we paying more than UNC?

**Staff Response:** *The portion of Friday Center Drive from the intersection with NC-54 to just past the southern-most entrance to the William and Ida Friday Center Building is a Town street and maintained by the Town. It provides public access to the Friday Center and to the Marriott Hotel.*

*The portion of Friday Center Drive from just past the Friday Center to the Hedrick Building is maintained by UNC and was resurfaced in 2016. The Town's contractor performed the work and UNC reimbursed the Town for the cost*
