I am writing to express concerns I have with the application for rezoning from R2 to R6 of 7516 Sunrise Road.

My family lives in the Stoneridge/Sedgefield neighborhood, off of Whitfield Road. Over the years, Whitfield has become more and more a major road for access between Highway 86 and Old Erwin Road, and Sunrise Road has become a shortcut for cars--and runners--- to go to East Chapel Hill High School and various businesses on Weaver Dairy Road. Both Whitfield Road and Sunrise Road are already carrying more traffic than ever intended for these country (and curvy) roads.

Sunrise Road has its own challenges. This road is used by many inexperienced drivers---the East Chapel Hill High School students as they travel from home to school and also at lunch to drive a back way to Bojangles. (Yes, our own kids told us about this!) The road is also used by the residents of Carol Woods Retirement Village, and while I've noticed they are cautious drivers, there have been instances where the drivers did not realize that they left no room at the side of the bridge for those persons who were running or walking. This road--including the part that includes the narrow bridge---is often used for runners, which includes the cross-country and track teams from East Chapel Hill as well as neighborhood runners and walkers.

Adding a new community with over 200 units will cause these issues to become more dangerous. With few streetlights, no bike lanes, a narrow bridge on Sunset, as well as a mixture of inexperienced drivers and older drivers, a new neighborhood of over 200 units would not be a safe addition.

Substantial upgrades to the roads of Sunrise and Whitfield would need to be completed before such a large community is developed in the area. May I ask, what are those plans for improving the roads and traffic patterns before this neighborhood could be added?

The back 17 acres of the Sunrise Road property is the most environmentally sensitive of the acreage there, which includes wetlands. The current plans do not take in the distances needed from the wetlands as well as the transmission lines.

Thank you for your time to reconsider these issues before moving ahead with any plans for the Sunrise Road project.

I would like to comment on the positives that can come from your approval of Weavers Grove.

Millard Fuller, founder of Habitat for Humanity, wrote his book *More than Houses, How Habitat for Humanity is Transforming Lives and Neighborhoods*, in 1999. I met Millard and his wife in 2000 when I attended a training session in Charlotte for new Board Chairs of local Habitat affiliates.

Millard signed my copy of this book during the training session. After volunteering with the Orange County Habitat affiliate for over twenty years, I can attest that the way Habitat for Humanity builds affordable homes with volunteers result in experiences far deeper than that of working with wood, nails, paint, and shingles.

One of the chapters of the book is on lasting friendships that can be created between:

future homeowners and their future neighbors homeowners and their volunteers and friendships between volunteers.

Many of my lasting friendships have been created by volunteering on a job site, at the Habitat Restore or with other Board members and Habitat Staff. Volunteers have a unique opportunity to cross age, gender, race, and social-economic status boundaries. Job titles are not brought to the job site.

One of my lasting memories was leading a group of corporate executives for a half-day work session. We were working on a deck. After about 30 minutes of work, I asked the executives if they were proud of their work. They admitted the spaces between boards weren't the best. We agreed to take up the boards and start over. We wanted the new homeowner to have a quality job.

Another chapter highlights stories about bridging religious, political, and cultural differences. I have seen how some residents in adjoining neighborhoods to new Habitat subdivisions are often very concerned about more traffic, stormwater runoff, and even additional "crime" from new neighbors. One of my lasting experiences is seeing families in existing neighborhoods eventually volunteering to work on the job site or to have their children bring a wagon full of food for lunch for the onsite volunteers. New homeowners show their appreciation to anyone helping them realize their dream of homeownership!

A third chapter discusses how Habitat builds neighborhoods around the world. Orange County Habitat for Humanity has been committed to sending local volunteers to help build homes in other countries.

Earlier this year, I met an Orange County Habitat volunteer who had been on an Orange County sponsored overseas work trip. He and his wife said it was the best experience in his life.

Orange County Habitat is also committed to building one home in another country for every home built in Orange County.

It is hard to believe Orange County has also seen the reverse. One of Habitat International's early overseas efforts was in a remote area of Zaire. A Habitat volunteer from Orange County invited the oldest grandson of the chief of the village he was working in to come to Orange County. The oldest grandson of the chief of this village has lived in Lockridge for over 25 years. He started a nonprofit called "Go Conscious Earth" (https://www.gcearth.org/) which is protecting over 1 million acres of virgin rainforest from international logging companies. His efforts to protect his homeland is very heartwarming. Many local residents are supporting his nonprofit.

On a personal note, our youngest daughter had a chance to fine-tune her auto mechanics skills by working for a year with the grandson of this village chief. After attending auto mechanics classes at Alamance Community College for a "gap year", our daughter graduated from college and was accepted by Standford for a Ph.D. program in physics. They both treasure the time they had to work together here in Orange County.

I believe if you approve Weavers Grove, you will be helping not only the 236 families that will live in these new homes but also help residents of Chapel Hill cross age, gender, and socio-economic boundaries.

The interpersonal relationships developed by folks from various walks of life while building safe, affordable, and entry-efficient Habitat homes have truly blessed our community!

The proposal is for a massive project, so can milestones be introduced to allow project truncation before it gets out of hand, rather than find out only at the very end that this has become a disaster that the local citizens will be forced to live with while the developers take their profits and race off, never to be seen or heard from again?
- 2) Parking in the new development- It looks like there are not enough parking spaces for the residents and guests. Can this be clarified?
- 3) Traffic flow 1: The developers appear to assume that everyone will be driving to Hillsborough, instead of Chapel Hill, Durham, etc. Those driving to Chapel Hill will be tempted to cut through the Chandler's Green neighborhood to avoid stop lights at Sunrise and by the High School.
- 4) Traffic flow 2: LUPA Analysis item 4 notes that more population density means more use of public transportation and walking. There might be some increase in usage, but my bet would be on more car traffic instead.
- 5) LUPA Analysis item 3 describes transitioning and buffering. It already can be quite noisy in this area when the trees lose their leaves. It expect that this development will result in many trees being lost and more noise than proposed currently.
- 6) Trees: The developers want to keep as many trees as possible, but who will be responsible for maintaining the trees in the new development if they become a problem? When development trees get diseased, which resident will be paying \$1200/tree for removal? If not addressed, the disease eventually could travel downwind to my trees.

In summary, I have followed this aggressive development for a while, and although progress is being made, this still has the feeling of a disaster waiting to happen.


