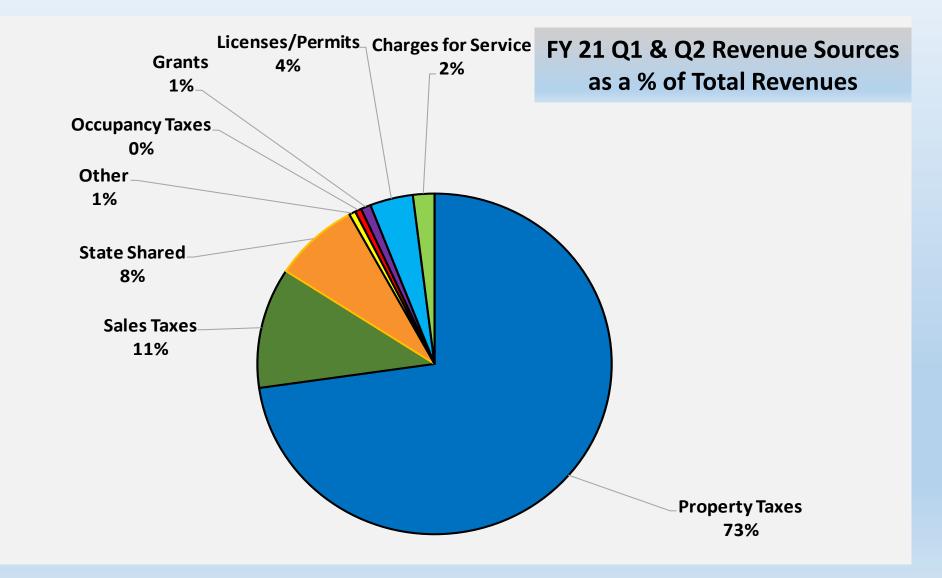

- Sales taxes are received by the Town three months in arrears
- Growth in sales tax is budgeted based on prior year actual receipts
- Town projected 5% decrease for FY 2021 collections
- \$485,573 additional sales tax collected in first 4 months of FY 2021; 4.13% growth
- Factors impacting sales: NC phased close orders; online sales; federal stimulus checks

General Fund FY 21 Q1 & Q2 Expenditures

- At the end of the 2nd quarter, we would expect to have spent about 50% of the budget; actual is at 43%
- Town has saved \$1 million in personnel savings from the hiring freeze
- Town has saved \$1.2 million in operating costs resulting from FY 21 budget cuts in the areas of maintenance, streets and vehicles and from close monitoring of large purchases

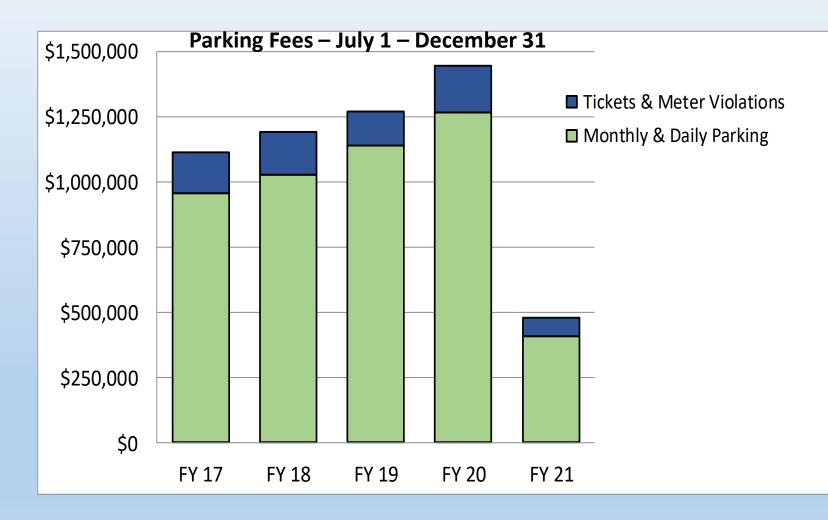




Transit Fund

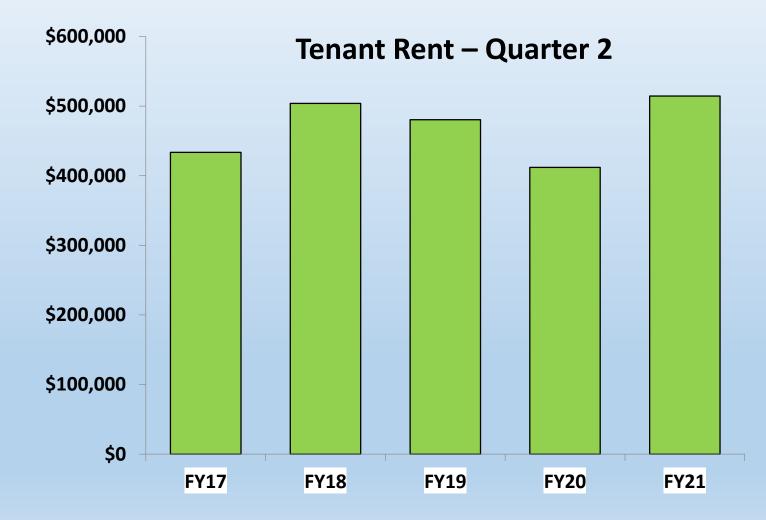
- Property taxes collected at 81% (comparable with prior years)
- Intergovernmental revenues low because FTA, state, & bus rapid transit funds typically received later in the year
- UNC & Carrboro contributions billed and collected
- CARES \$ allocation
- Personnel expenditures are on target at 47% of budget

Parking Fund (Impact due to COVID-19)



- As a result of COVID-19, the Town stopped charging March - July
- Parking fees resumed August 1st at new rates (\$1.50 hourly & \$125 monthly)
- Monitoring expenses wherever possible to help offset revenue shortfalls
- Evaluating short-term strategies to help parking sustain through impacts of COVID-19

Housing Fund



- Tenant rent fairly consistent with prior year revenues
- Annual federal grant funds drawn; no CARES \$ drawn
- Personnel expenditures are on target at 49% of budget

Stormwater Fund

- Stormwater fees are billed on same schedule as property taxes
- \$1.2 million in FY 21 (July November; 1 month delay in collections)
- Personnel expenditures are on target at 50% of budget
- Booker Creek Storm Basin Park under construction
- 2018 bond issuance debt service
