I also support making Ridgefield and Walnut egress only as a part of this project, similar to what was done at the end of Rogerson and Oakwood.

			aware of. First, the heights of the west (back) property lines of the 400 and 300 blocks of Hickory Dr., which differ by about 7' to 10', have evidently not been surveyed. The 300 block is the lower of the two. Our back yard in the 300 Hickory block is about as high as the pavement on Fordham Blvd. Is the path to be the same height for the two blocks? If this is the case, will a retaining wall need to be built on the 400 block to keep the path level? Or will the path on the 400 block have an uphill and a downhill on either end? Could this latter situation become a safety issue for young children, who are just learning triking and biking skills? Second, we have seen no survey of reports of accidents at Fordham Blvd and Willow Drive. Our home is within hearing distance of big crashes at or near that intersection—I would guess at a rate of about four big ones per year, bringing ambulances, police, and sometimes fire trucks. One big accident occurring in the northbound lanes of Fordham Blvd.(ca. 18 Oct 2018) began near the south end of the 300 block of Hickory with one car somehow wound up tucked into the existing bushes, and the second car flipped onto its top 20' feet or so south of Willow. This accident spanned nearly the entire back side of 300 Hickory Dr. blocklt was the existing trees that stopped these wildly out-of-control cars. What if there were an unprotected bike path there, instead of the trees? Further, this past fall has seen a sharp increase in the amount of traffic on Fordham Blvd.Apartments on Fordham near Elliott Road will add more vehicular traffic on Fordham.
