**RESOLUTION AUTHORIZING THE TOWN MANAGER TO EXECUTE A CONTRACT WITH
SUNROCK INDUSTRIES LLC IN AN AMOUNT OF \$1,565,434.10 FOR STREET
RESURFACING (2025-06-25/R-2)**

WHEREAS, the Town of Chapel Hill solicited formal bids for street resurfacing on the Town website on May 7, 2025, in accordance with G.S. 143-129; and

WHEREAS, five responsive bids were received and opened on May 20, 2025; and

WHEREAS, the responsive bids were evaluated, and Sunrock Industries LLC was determined to be the lowest responsive, responsible bidder; and

WHEREAS, the bid permits an increase or decrease of up to 25% in the scope of work.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Town of Chapel Hill that the Council authorizes the Town Manager to execute a contract and any necessary change orders with the lowest responsive, responsible bidder, Sunrock Industries LLC in an amount of \$1,565,434.10.

BE IT FURTHER RESOLVED that the Town Manager is authorized to extend the base bid contract twice at the same base unit price by a one-year contract addendum if mutually agreeable to the Town and Sunrock Industries LLC.
