CDBG Program Overview

- The Town receives CDBG funding annually through the U.S. Department of Housing and Urban Development (HUD) for:
 1. Providing decent affordable housing
 2. Creating suitable living environments
 3. Expanding economic opportunity
- Entitlement community designation



CDBG National Objectives

- 1. Benefit low/moderate income households**
 - Households earning less than 80% Area Median Income (AMI=\$86,400; 80% AMI = \$69,100 for household of 4)
- 2. Aid in the prevention or elimination of slum or blight**
- 3. Meet an urgent need**

3. Housing Rehabilitation
4. Public Facilities
5. Public Services



CDBG Funding

Recommended Affordable Housing Activities

1. Acquisition and Rehabilitation- \$60,000

- ❑ 1 Homeownership Unit
- ❑ *Full request*

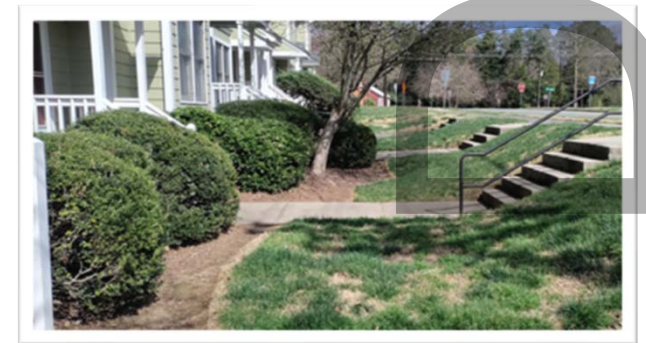


2. Down Payment Assistance - \$20,000

- ❑ 1 Homeownership Unit
- ❑ *Full request*

3. Townhome Repair - \$25,000

- ❑ Up to 14 rehabbed homes
- ❑ *Full request*



Recommended Affordable Housing Activities

4. Low-Income Homeownership Program - \$90,000

- ❑ Community Empowerment Fund
- ❑ \$10,000 for housing counseling
- ❑ \$80,000 for down payment assistance
- ❑ *Increased award*

5. Home Preservation - \$165,600

- ❑ \$38,100 for administration to Rebuilding Together of the Triangle
- ❑ \$127,500 for at least 12 rehabbed homes
- ❑ *Increased award*

6. Neighborhood Revitalization - \$155,684

- ❑ Acquisition, rehab, demolition, public improvements
- ❑ *Balance of CDBG Award*



Recommended Public Service Activities

15% Cap = \$63,351

4. Summer Youth Employment Program - \$25,000

- Town Project
- Required \$25,000*

5. Homeless Case Management – \$34,022

- Inter-Faith Council for Social Services
- Requested \$106,460*

6. Children’s Parents Classes - \$4,329

- Exchange Club’s Family Center
- Balance of Public Services Cap*
