Madame Mayor and Council Members:

At your upcoming Wednesday business meeting, you will be considering the following:

Consider Amending the Town Code of Ordinances to Include the Architecture 2030 Challenge Fossil Fuel Reduction Targets.

I strongly urge you all to vote in favor of amending the Town Code! The ESAB first considered this issue in the Fall of 2016, and after Staff fully examined and vetted adopting the AIA-2030 targets for Town-owned buildings, we strongly supported the Staff's position on this to amend the Town's Green Building Code accordingly. As the original ESAB petition states, this change is in keeping with last year's resolution by the Council for Chapel Hill to do all it can to support the Paris Climate Accords. Buildings use almost 50% of all the energy consumed in the US for heating, cooling, and for producing hot water, so constructing and renovating more energy efficient buildings go far in reducing the US carbon footprint.
