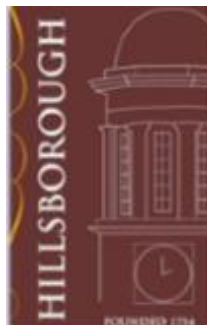

Orange County HOME-ARP Funds

Orange County's HOME-ARP Award

- The American Rescue Plan allocated \$5 billion to the HOME Program for:
 - Development of affordable housing
 - Creation of non-congregate shelter
 - Rental assistance
 - Supportive services
- The Orange County HOME Consortium received \$1.3 million

Who does HOME-ARP serve?

- Homeless or at-risk of homeless
- Fleeing or attempting to flee domestic violence
- Households facing the greatest risk of housing instability (e.g. low-income households)
- Veterans

The HOME Consortium can establish prioritization for HOME-ARP funded projects or services

- E.g. Coordinated Entry through the Housing Helpline

HOME-ARP Allocation Plan

- The Orange County HOME Consortium is seeking input on how to use the HOME-ARP funds
- The allocation plan will describe housing and service needs in the County and make funding recommendations for general uses
 - Specific projects do not need to be identified yet
 - More details about the funding application process to come
