Dear Agency Member,

The Town of Chapel Hill has started the project development, environmental, and engineering studies for project HO-0013 in Chapel Hill, Orange County, NC. This project proposes to upgrade the existing signalized intersections at West Franklin Street/North Graham Street and East Franklin Street/Columbia Street. Upgrades would include metal signal poles with mast arms and minor curb and gutter repairs around the base of the poles. The coordinates of this project are approximately 35.909874, -79.064216 and 35.913147, -79.055793.

The project is included in the NCDOT 2024-2033 State Transportation Improvement Program (STIP) with right-of-way acquisition scheduled to begin in Fiscal Year (FY) 2025 and construction beginning in FY 2026. This schedule is subject to change. The project is federally funded, and a federal environmental document will be prepared; a Categorical Exclusion is anticipated. A scoping meeting is not anticipated at this time.

Attached for your review and comment is a vicinity map and an environmental features map for the proposed project. We would appreciate any information you may have that would be helpful in evaluating potential environmental impacts of the project. If applicable, please identify any permits or approvals that may be required by your agency.

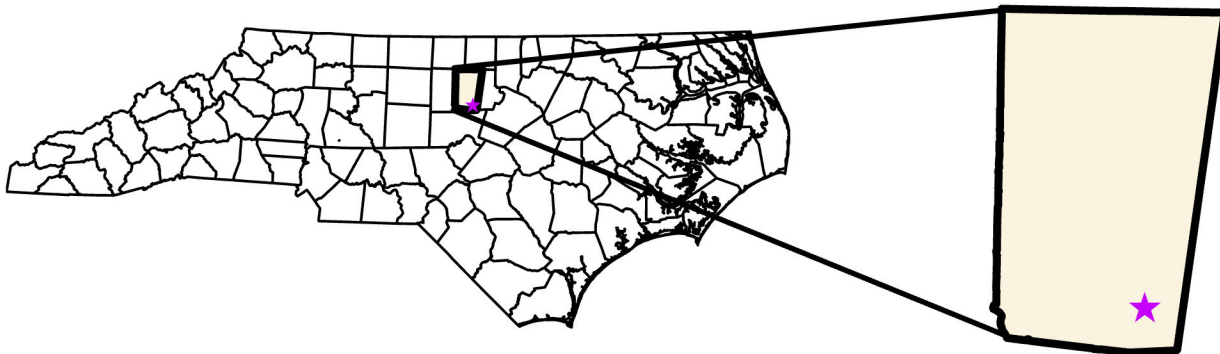
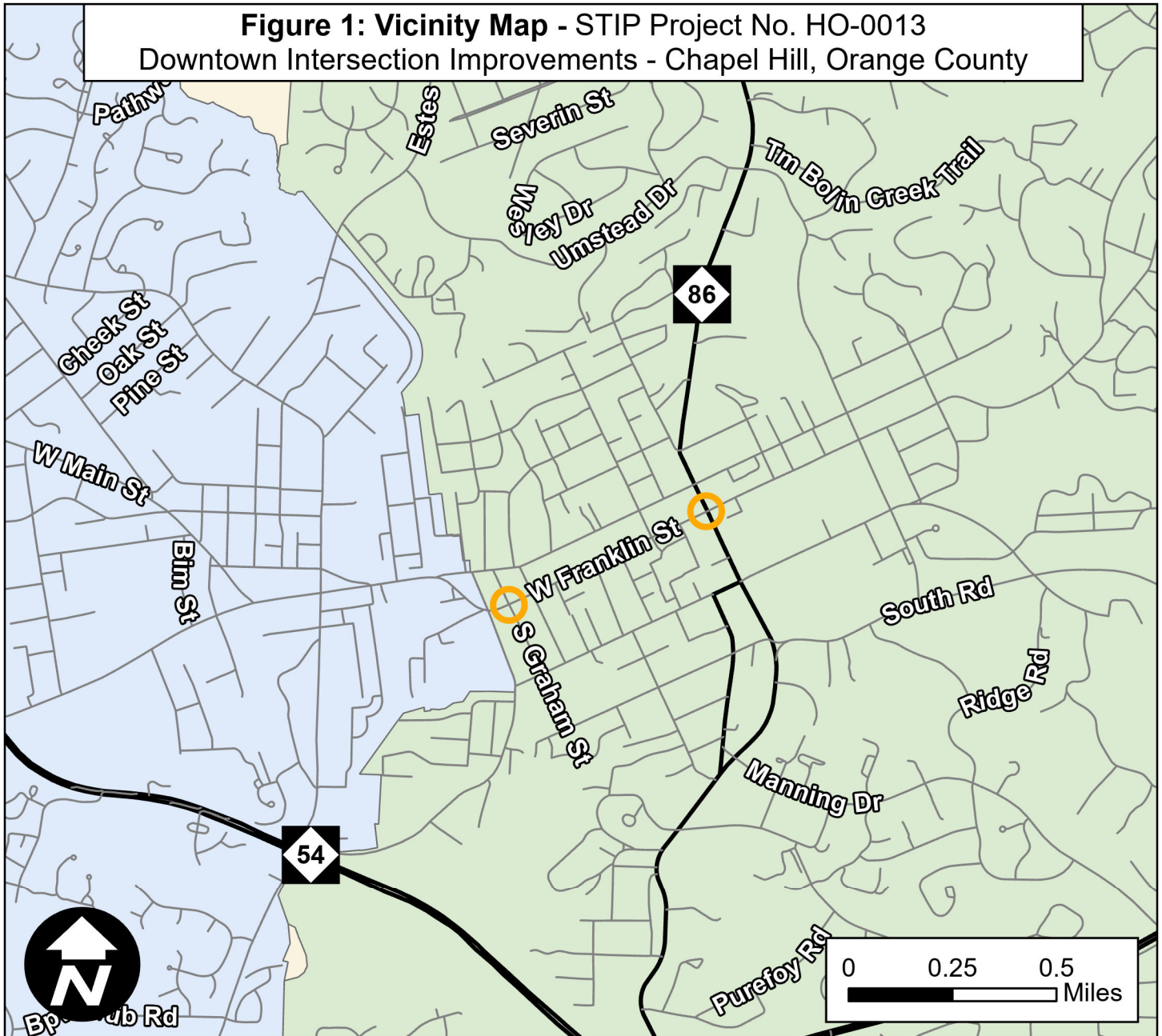

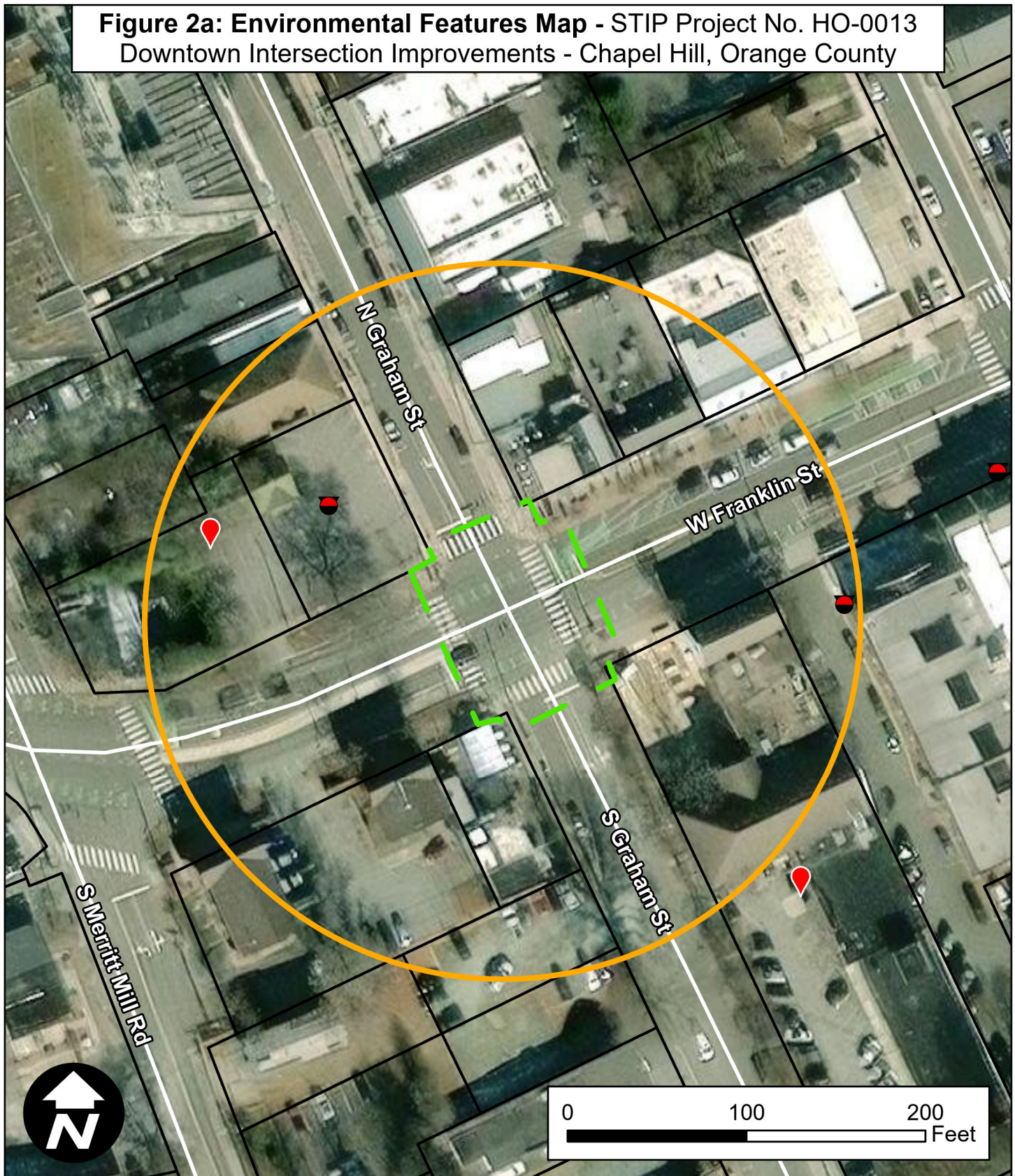
Figure 1: Vicinity Map - STIP Project No. HO-0013

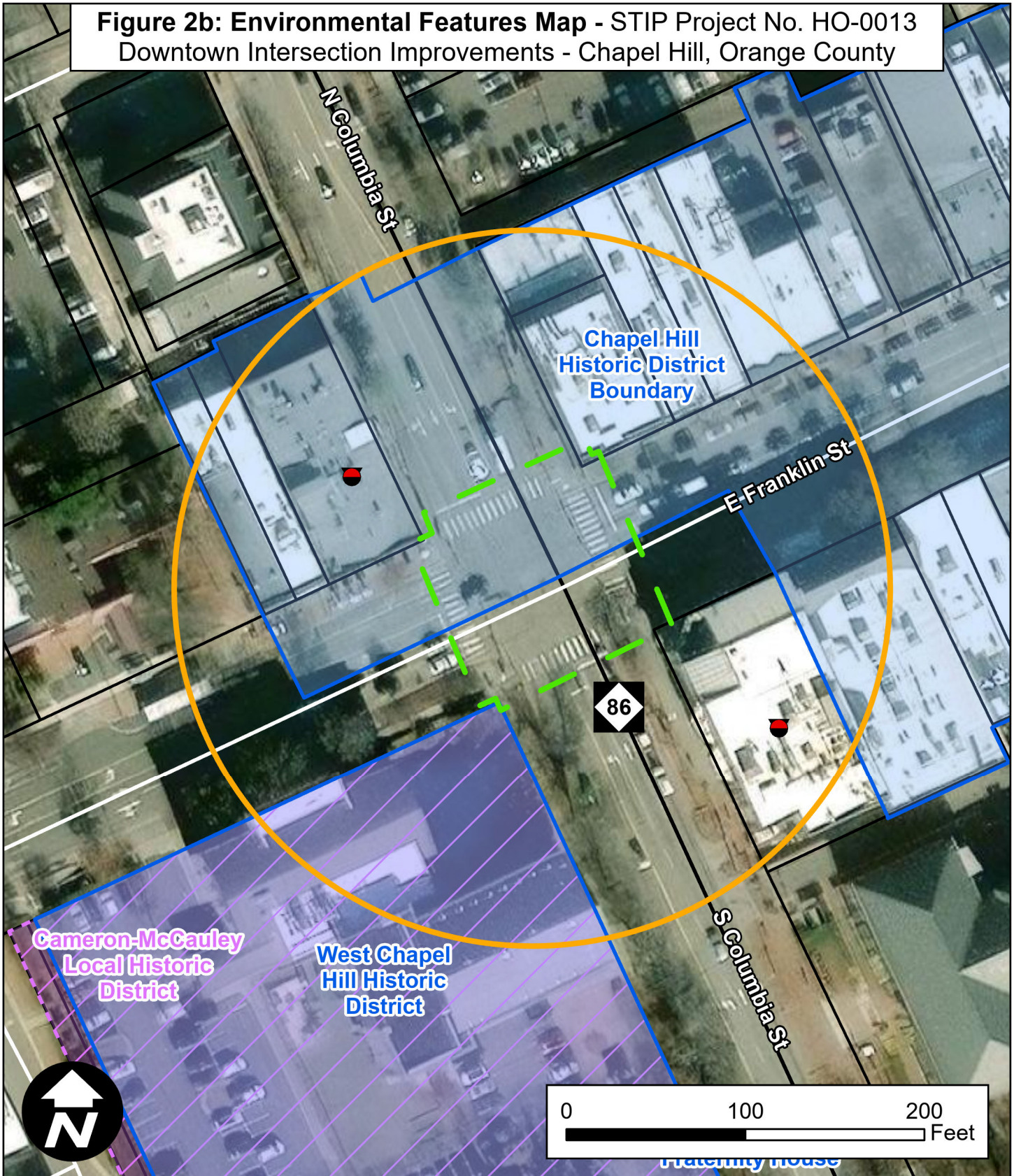
Figure 2a: Environmental Features Map - STIP Project No. HO-0013
