

AN ORDINANCE AMENDING CHAPTER 21 OF THE CODE OF ORDINANCES TO REGULATE SPEEDS IN ACCORDANCE WITH THE VISION ZERO RESOLUTION

WHEREAS, the Council of the Town of Chapel Hill adopted a Vision Zero Resolution (2021-10-13/R-2) that commits to eliminating traffic fatalities and serious injuries; and

WHEREAS, higher speeds correspond to more serious injuries and fatalities, thus speed management is an objective of reaching the Vision Zero goals outlined in Resolution 2021-10-13/R-2); and

WHEREAS, a default Town-wide speed limit of 25 mph instead of 35 mph better reflects the Town’s commitment to Vision Zero; and

WHEREAS, four Chapel Hill Carrboro City Schools do not currently have designated school zones in the Town Code of Ordinances; and

WHEREAS, studies show that sign changes with nothing else can still impact average driver speeds; and

WHEREAS, Neighborhood Slow Zones are a nationally recognized traffic calming method, defined by the National Association of City Transportation Officials as “specifically designated areas with slower speeds than otherwise similar streets in the same jurisdiction” and “[n]eighborhood-scale or site-specific zones are useful for addressing high-priority areas”.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Town of Chapel Hill as follows:

Section 1. That Chapter 21, Article II, Sec. 21-10 of the Code of Ordinances, Town of Chapel Hill, North Carolina, is hereby amended to read as follows:

“Sec. 21-10. ~~One-way streets Reserved.~~”

~~Upon certain public streets, described in this section, vehicular traffic shall move only one way as indicated by traffic signs:~~

- ~~(a) Traffic on Pickard Lane shall move from East Rosemary Street to East Franklin Street.~~
- ~~(b) Traffic on Cobb Terrace shall move north and east clockwise around the circle upon entering at north end of Henderson Street.~~
- ~~(c) Traffic on Evergreen Lane shall move only in an easterly direction.~~
- ~~(d) Traffic on Briarbridge Lane between Pittsboro Road and Briarbridge Valley shall move only in a northerly direction after entering the intersection at Pittsboro Road and Briarbridge Lane.~~
- ~~(e) Traffic on Robertson Lane between the Village Apartments and the Presbyterian Church shall move only in a northerly direction from Franklin Street to Rosemary Street.~~
- ~~(f) Traffic on Short Street between Church Street and Pritchard Avenue shall move only in an easterly direction.~~

- ~~(f.1) Traffic on Coolidge Street between Columbia Street and Old Pittsboro Road shall move only in a westerly direction.~~
- ~~(g) Traffic on Chapel Street shall move only in a southerly direction.~~
- ~~(h) Traffic on Cotton Street, from McDade to Brooks Street shall move only in a northerly direction.~~
- ~~(i) Traffic on Brooks Street from Cotton Street to Chapel Street shall move only in an easterly direction.~~

- ~~(l) Traffic on South Columbia Street from Pittsboro Street to Cameron Street shall move only in a northerly direction.~~

- ~~(p) Traffic on Carr Street between N. Columbia Street to Pritchard Avenue shall move only in a westerly direction."~~

Section 2. That Chapter 21, Article III, Sec. 21-11 of the Code of Ordinances, Town of Chapel Hill, North Carolina, is hereby amended to read as follows:

"Sec. 21-11. Speed regulations.

Sec. 21-11.1 GENERAL LIMIT. It shall be unlawful for any person to operate, or cause or permit a motor vehicle of any kind to operate at a speed greater than twenty-five (25) miles per hour (MPH), except upon streets which are part of the State highway system, and except as provided in this article.

~~(C)~~ SCHOOL ZONES. Limits set pursuant to the following sections shall become effective when signs are erected giving notice of the school zone, the authorized speed limit of twenty (20) miles per hour, and the days and hours when the speed limit is effective. These restrictions apply on streets that are not a part of the State highway system unless otherwise provided in this article.:

(611) Kildaire Road from a point five hundred (500) feet east of the eastern boundary line of the Mary Scroggs Elementary School to the eastern boundary of the Mary Scroggs Elementary School.

(712) Meadowmont Lane from Simerville Road to a point five hundred (500) feet east of the eastern boundary line of the Rashkis Elementary School.

(811) Prestwick Road from a point five hundred (500) feet east of the eastern boundary line of the Glenwood Elementary School to the eastern boundary line of the Glenwood Elementary School. Hamilton Road from NC-54 Raleigh Road to Prestwick Road.

~~(B) (1) [Reserved.]~~

(12) High School Road from Seawell School Road to Homestead Road.

(13) Weaver Dairy Road from a point two hundred and forty (240) feet east of Sunset Drive to a point one hundred (100) feet west of Muir Lane.

Limits set pursuant to these sections may be enforced thirty (30) minutes prior to and following the beginning of school hours and thirty (30) minutes prior to and following the ending of school hours.

Limits set pursuant to these sections may be enforced only on days when school is in session.

Limits set pursuant to these sections are enforceable as criminal offenses and punishable as a misdemeanor, in accordance with N.C.G.S. 14-4, and shall subject violators to a fine of five hundred dollars (\$500.00) or imprisonment for not more than thirty (30) days.

Sec. 21-11.7 HOSPITAL ZONES.

~~(D) HOSPITAL ZONE.~~ It shall be unlawful for any person to operate or cause or permit to be operated a motor vehicle of any kind at a speed greater than twenty (20) miles per hour on the Pittsboro Road known as U.S. Highway 15-501, between a point of said road or highway located approximately one hundred (100) feet north of the northern entrance to the parking area set aside for the North Carolina Memorial Hospital and another point on said road or highway located approximately one hundred (100) feet south of the southern entrance to the parking area set aside for the North Carolina Memorial Hospital, each of said points being identified by highway markers bearing the words "Hospital" and "20 M.P.H."

Sec. 21-11.8 NEIGHBORHOOD SLOW ZONES.

(A) The Town Manager may establish Neighborhood Slow Zones in which it shall be unlawful for the driver of any vehicle to exceed the speed limits posted by the traffic engineering division of the Town. The traffic engineering division shall erect signage at all entry points to a Neighborhood Slow Zone with the zone's posted speed limit.

(B) Upon the establishment of Neighborhood Slow Zones pursuant to paragraph (a) of this subdivision, the Annual Vision Zero Report shall include a listing of the location of all Neighborhood Slow Zones. This report shall include a determination of whether the department shall make the speed changes permanent on the identified streets. These changes, if adopted, shall be set out in schedule II, Sec. 21.64.

(C) Limits set pursuant to these sections are enforceable as criminal offenses, in accordance with N.C.G.S. 14-4. and shall subject violators to a fine of five hundred dollars (500.00) or imprisonment for not more than thirty (30) days.

Sec. 21-11.9 HORSES.

~~(E) HORSES.~~ No person shall ride or drive a horse through the public streets at an unusually high speed."

Section 3. That Chapter 21, Article VII, Sec. 21-63 through Section 21-64 of the Code of Ordinances, Town of Chapel Hill, North Carolina, is hereby amended to read as follows:

Sec. 21-63 Schedule I. ONE-WAY STREETS

Upon certain public streets, described in this section, vehicular traffic shall move only one way as indicated by traffic signs:

- (a) Traffic on Pickard Lane shall move from East Rosemary Street to East Franklin Street.
- (b) Traffic on Cobb Terrace shall move north and east clockwise around the circle upon entering at north end of Henderson Street.
- (c) Traffic on Evergreen Lane shall move only in an easterly direction.
- (d) Traffic on Briarbridge Lane between Pittsboro Road and Briarbridge Valley shall move only in a northerly direction after entering the intersection at Pittsboro Road and Briarbridge Lane.
- (e) Traffic on Robertson Lane between the Village Apartments and the Presbyterian Church shall move only in a northerly direction from Franklin Street to Rosemary Street.
- (f) Traffic on Short Street between Church Street and Pritchard Avenue shall move only in an easterly direction.
- (f.1) Traffic on Coolidge Street between Columbia Street and Old Pittsboro Road shall move only in a westerly direction.
- (g) Traffic on Chapel Street shall move only in a southerly direction.
- (h) Traffic on Cotton Street, from McDade to Brooks Street shall move only in a northerly direction.
- (i) Traffic on Brooks Street from Cotton Street to Chapel Street shall move only in an easterly direction.
- (j) Reserved.
- (k) Reserved.

- (l) Traffic on South Columbia Street from Pittsboro Street to Cameron Street shall move only in a northerly direction.
- (m) Traffic on Pittsboro Street from Cameron Avenue to South Columbia Street shall move only in a southerly direction.
- (n) Davie Circle shall be a one-way traffic lane wherein traffic shall move only in a counter clock-wise direction from its intersection with Jones Street to an intersection where the entrance from Franklin Street meets the circle.
- (o) Old Durham Road from US 15-501 to the eastern corporate limits.
- (p) Traffic on Carr Street between N. Columbia Street to Pritchard Avenue shall move only in a westerly direction.

Sec. 21-64 Schedule II. NEIGHBORHOOD SLOW ZONES

In accordance with Sec 21-11.3 and when signs are erected giving notice thereof, Neighborhood Slow Zones speed limits shall be as set forth in this schedule upon those streets or portions thereof:
