Subject: Opposition to Active Adult Housing project

Dear Mayor and Town Council members:

I write to express my opposition to the Active Adult Housing Project proposed for 2217 Homestead Road (Project #17-096). As a resident of the nearby Homestead Village neighborhood, this project as proposed by Gurlitz Architectural Group is simply too dense for the 17-acre parcel and is not in keeping with the adjoining residential communities. This project would have a significant negative impact on Homestead Village and surrounding neighborhoods, and I strongly urge you to oppose it.

I oppose this project for the following reasons:

- 1. This project would require a zoning change from R2 to R5, which I don't believe is compatible with the residential character of this section of Homestead Road, which is zoned R2 and includes primarily single-family homes and townhome communities.
- 2. The Active Adult Housing project calls for a 190-unit, 232,000-square-foot building on a very small parcel of land, which means the developer has to build a taller, more dense building that is incompatible and inappropriate for this area of Homestead Road.

If this level of density sounds familiar, it should. It's close to what several developers tried to build on the site of the current Courtyards community, which sits on about 30 acres. You may remember The Retreat project, which Homestead Village opposed and called for 190-200 apartment units for UNC students on the 30-acre parcel. The density now proposed for the Active Adult Housing project would be on about half that acreage. This is not thoughtful planning.

Homestead Village asked for and supported your efforts to approve a single-family housing community, which is what we have now with the Courtyards development. Now, we're asking for the same kind of intelligent planning and appropriate project for 2217 Homestead. The Gurlitz project is not such a project.

3. There are no plans for the town to widen this section of Homestead Road, which already has a half dozen or more completed or ongoing housing development projects impacting traffic. This dense a project would only further clog this section of Homestead Road and diminish the quality of life for the residents who live nearby. I support increasing the residential and commercial tax base in Chapel Hill because it benefits all of us, as long as it's done intelligently and with proper infrastructure in place.

Those of us in Homestead Village are still waiting for the town to finish extending the sidewalk on Homestead Road and nearby Seawell School Road, which many of us supported at the polls by voting for the bond referendum. I'm told this won't be finished until fall 2019 at the earliest. We are already feeling underserved as residents and voters and now we have yet another ill-advised development project to contend with. Enough is enough!

I urge you to oppose this project as proposed by the Gurlitz Architectural Group.
