Mayor Anderson presented the proclamation to Pilar Rocha-Goldberg from El Centro, and Vicky Cruz Raleigh Immigration Law Firm. The proclamation emphasized the Town's commitment to inclusion and equity.

11.	Tropical Storm Chantal Overview	[25-0408]
	Emergency Preparedness and Risk Management Director Kelly Drayton presented a comprehensive overview of the Town's response to Tropical Storm Chantal. She described the storm as an unprecedented event, with rainfall levels placing it in the 500-1000-year flood category. Despite limited warning, the Town's emergency protocols were activated swiftly. The Emergency Operations Center was opened, and 72 water rescues were conducted within Chapel Hill. Over 2,300 emergency calls were received by Orange County 911 during the storm.	
	Ms. Drayton described the immediate aftermath including the coordination with Orange County to open shelters and relocate 37 public housing units to hotels. Staff also worked with the Department of Social Services and the Town's Crisis Team to provide wraparound services to displaced residents. Ms. Drayton provided an overview of damage assessments

conducted for 215 residential properties and 101 businesses. The Town is currently awaiting a federal disaster declaration for public assistance, although declarations for individual and small business assistance have already been received.

Council members raised concerns about the long-term closure of greenways, the need for temporary infrastructure solutions, and the importance of clear communication with residents.

Council emphasized the role of greenways as essential transportation corridors and requested updates on funding strategies, staff investigation of lower-cost natural surface trail options, utilizing informal trails to support mobility and support bike/pedestrain connectivity, temporary trail options, and mutual aid resources.

Ms. Drayton confirmed that a long-term recovery group has been formed and that \$84,000 has been raised through a community giving fund. An after-action report is being developed in partnership with Orange County and will be published in November.

This matter was received and filed.

12. Funding Plan for the local affordable housing funding program.

[25-0409]

Affordable Housing Manager Emily Holt presented the FY26 funding plan for the local Affordable Housing Funding Program. Ms. Holt provided an overview of the plan that allocates \$4 million to two projects: Hillside Trace, a 190-unit affordable rental development by Taft Mills Group, and a Hope NC project to acquire four units in Weaver's Grove for adults with intellectual and developmental disabilities.

Ms. Holt stated the two other applications-Habitat for Humanity's Carver Street project and a proposal from Community Home Trust-were not recommended for funding due to lower scores and lack of project readiness

Heather Ferrell, Kathy Atwater, George Barrett, and Jennifer Player expressed support for the Carver Street project, citing its alignment with community values and its potential to increase Black homeownership in the Northside neighborhood.

Nate Broman-Fulks thanked Council for support of the Hillside Trace Affordable Housing Development project.

Council members emphasized the importance of homeownership opportunities and expressed concern about the potential loss of momentum for the Carver Street project. Staff explained that the project could be considered in future funding rounds and reaffirmed the Town's commitment to supporting both rental and ownership housing. Council also discussed the limitations of current bond allocations and the need to balance funding across multiple priorities.

Zoning Atlas Amendment: The Zoning Atlas Amendment, to change the zoning designation on this property, is Legislative. The Council receives and considers public comment on the merits of the proposed rezoning, including opinions, when making Legislative decisions.

 Open a Legislative Hearing for a Conditional Zoning Application at 5640 Old Chapel Hill Road [25-0410]

At the applicant's request, the Council opened and continued the legislative hearing for a conditional zoning application at 5640 Old Chapel Hill Road to September 24, 2025.

A motion was made by Council Member Berry, seconded by Council Member Miller-Foushee, that the Council open the legislative hearing. The motion carried by a unanimous vote.

**14.** Open a Legislative Hearing for a Conditional Zoning Application at 701 Martin Luther King Jr. Blvd

[25-0411]

Senior Planner Katherine Shor and representatives from Landmark Properties presented a conditional zoning application for a mixed-use development at 701 Martin Luther King Jr. Blvd.

Development Manager Bryan Boyles shared an overview of Landmark Properties, site location, site plan, conceptual rendering, and proposed site section. The proposed project includes up to 200 residential units, 10% of which would be affordable, along with ground-floor retail, a public plaza, and structured parking. The site is located near a future Bus Rapid Transit stop and is intended to support transit-oriented development.

Council members expressed general support for the project's density and location but raised several concerns including the affordability levels with a request to increase the share of units at 60% affordable median income (AMI), the need for a diverse unit mix to accommodate families and non-student residents, and the potential to reduce parking to better align with the Town's sustainability goals. Council also discussed the environmental impacts of the project, particularly regarding stormwater management and tree canopy loss. The applicant was asked to return with additional information on affordability, parking strategies, and unit configurations.

A motion was made by Council Member Berry, seconded by Council Member Miller-Foushee, that the Council continued the Legislative Hearing to October 8, 2025. The motion carried by a unanimous vote.
