Mayor and Council:

I would like the Council to take appropriate action to accept the staff recommendations regarding the potential use of the current police building site for appropriate use for the Town and the alternatives the Council approves for the developer to pursue. These sites were so far more contaminated than any thing like the coal ash matter here in Chapel Hill. My only question is why the University is not a party in this matter.

Best wishes as you deliberate this matter and finally bring it to a conclusion. The police department deserves better!
