The height and scale of the wet lab office building proposed for 150 East Rosemary Street was from the very beginning inappropriate for this location and damaging to the historic character of the 100 block of East Franklin Street as well as the adjacent neighborhoods in the Franklin-Rosemary Historic District. A 60-foot-tall building towering over the Post Office, a National Register Historic Structure, would have been bad enough. Now, the developer proposes a 100-foot-tall wet lab building that will dwarf the 100 block of East Franklin Street. You are going to vote to approve changes in zoning

to build this monstrous structure? Really? How will this revitalize downtown Chapel Hill? Anyone paying attention can see what is happening. Slowly but surely there will be no recognizable downtown Chapel Hill, and the destruction of its unique historic character, especially in the 100 block of East Franklin Street, will be a loss to citizens of Chapel Hill, UNC alumni, and the state of North Carolina.

"Opportunity Zone," should never have been applied to Chapel Hill, which is not economically depressed.
