Dear Mayor Hemminger and Town Council Members:

The multi-purpose synthetic turf fields at Cedar Falls Park were originally installed in 2013 and are past their life span due to heavy utilization by many sports programs. Their current condition is troubling. A growing number of players, parents of players, and coaches are raising concerns about their continued use. As the grass fibers have continued to break down due to age and heavy (but anticipated) use, the crum rubber infill material is increasingly exposed and compaction of the surface is a great concern for safety. We are concerned that if the field surface is not replaced quickly – within the next several months – that the fields will become unusable due to safety or maintenance concerns.

We request that the Town of Chapel Hill fund the complete replacement of the synthetic turf at the site from American Rescue Plan funds or another readily available source so that the fields can remain in use for the next (up to) ten year period. We recommend that the Town utilize the cork infill material used several years ago at Homestead Park when completing the project. The cork infill is more environmentally friendly and safer than traditional crumb rubber material.

The fields at Cedar Falls Park are crucial to our sports programs' operations and ability to continue to serve area residents with quality opportunities. Collectively, our clubs serve thousands of individuals living in Chapel Hill, Carrboro, and Orange County playing sports such as soccer, field hockey, rugby, and lacrosse. There are no suitable other locations in the area that our programs could use if these fields were to be closed. Additionally, we are aware that the field rentals at Cedar Falls are a significant source of revenue for the Town, typically generating \$200,000 per year from rental fees. Closure of the fields would result in the loss of this revenue.

We further request that the Town identify funds to pave the parking area at Cedar Falls Park. With the current gravel surface, potholes continue to be problematic and routinely cause issues for vehicles passing within the lot. The planned renovation of the tennis courts will bring additional visitors to this already busy site, which will cause more wear and tear on the existing unpaved surface. We are concerned that the condition of the parking lot will deteriorate further causing more concerns with the families that we serve.

Thank you for your consideration of what we believe to be important requests for the benefit of our community and park system.


SUBJECT: Town's Excess Funds

DATE: March 16, 2022

On March 15, 2022, the Parks, Greenways, and Recreation Commission voted unanimously 9-0 to forward to the Council a request to allocate funding from the American Rescue Plan Act or any other source which is readily available for the East Section of the Morgan Creek Greenway. The Commission desires to see this crucial link in the Town's southern trail network funded and constructed quickly.

This section adds .4 mile to the existing greenway, connects eastward to Merritt's Pasture, and links to Meadowmont, Eastgate, and beyond. This action is consistent with the joint Parks, Greenways and Recreation Commission and Transportation and Connectivity Advisory Board action/endorsement on March 16, 2021, and is a project identified in the Mobility and Connectivity Plan.

Approximately ten community members participated in the 3/15 meeting to support the project.
