I recently read the Town Manager is proposing a half cent tax hike on the Town's Budget.

I've lived in Chapel Hill my entire life. Because of my business (and former restaurant) I got to know many of its citizens. The tax rates have always steadily gone up year after year. The past mayors and Councils have approved dozens of new developments with the logic being these developments would increase the tax base and the tax revenues. The logic has not proved itself. I have witnessed many of my Chapel Hill friends, neighbors, and customers share with me their dislike of seeing these monstrous developments (these apartments resemble those of Communist East Germany back in the 50's and 60's). Many share with me they intend to sell and move because their high property taxes eat away at their family budget.

Mayor Hemmiger and Council members,

While I recognize the need for affordable housing in Chapel Hill, I strongly oppose developing any and all parts of the Legion property to address the housing shortage.

1) First and foremost, the Legion property is the last large green space in this section of Chapel Hill. There are no other comparable green spaces in this area. Once a natural area such as the Legion property is developed, it cannot be "undeveloped." The original ecosystem is lost.

- 2) Many Chapel Hill residents currently utilize the property. It is very popular with walkers and joggers. Students walk to and from Ephesus Elementary School via Legion property. The wooded trails provide shaded walking paths in the summer when excessive heat greatly restricts outdoor activities. Residents also bike, fish, and simply appreciate nature on the property. The East Chapel HIll High School Monarch Butterfly Club has planted a beautiful butterfly garden there. Numerous volunteers continue to nurture the property, removing invasive species and planting native wildflowers to encourage a healthier ecosystem. - 3) Preserving the Legion property positively impacts the health of Chapel Hill residents. There are numerous health benefits for people who have regular access to natural areas. Simply being in nature lowers blood pressure, heart rate, and levels of stress hormones. Natural areas, especially those with trees, also reduce air pollution. The beneficial effect that the Legion property has on Chapel Hill's air quality becomes increasingly significant given the numerous apartment complexes and parking decks going up just minutes away. Think for a moment about the increase in cars and traffic to this area from the recent onslaught of development (from the Trilogy Apartment Complex, The Hartley, The Berkshire, etc.). Fuel emissions are bound to go up. We need to preserve natural areas to help mitigate the added pollution in our environment. Some of you campaigned with promises to protect the environment. Here's an opportunity to follow through.

Speaking of the recent development in this area, why wasn't affordable housing prioritized for those projects-projects that didn't threaten the last remaining large green space on this side of Chapel Hill? It seems to me that the town is only now realizing it erred tremendously on the side of luxury apartments at the expense of affordable housing. I urge you, don't try to fix one mistake with another. Developing the Legion property to offset the town's previous shortsightedness, would, itself, be short sighted.

Due to the the development on Ellis Rd and amount of growth in the "Blue Zone', and passing of which led to the ejection of the previous council and your election as Mayor and many of the council, the area is overpopulated for the amount of open space. South Chapel Hill has the Southern Park, whereas this area, in spite of its now density, has no significant public park open space. The Legion properly is the last chance to provide such a possibility. It is only fair that this part of town is treated equally to the Southern Village and associated areas.

We understand the need for low income housing - housing is ridiculously expensive in Chapel Hill and surrounding area. However, we have rampant development with no effort by the council to enable and force these developments to provide such housing.

Thank you Council members. I'm Jennifer Gill, an IFC staff member.

In October 2020 we were about six months into the pandemic. Some IFC services were located in Old Town Hall on the corner of Rosemary and Columbia – a space that was provided rent-free to IFC by the Town of Chapel Hill. It was a chilly and wet October day for IFC's Walk to the Polls event. And it is a day I'll always remember because it's when I fully understood what IFC is all about.

Brand new to IFC's staff, I was conditioned to office work. I thought surely the event would be canceled due to weather. Nope. Instead, an unlikely group of staff, volunteers, and people who access IFC services donned rain gear and trickled into the parking lot, working together to stabilize and raise canopies under which we would gather.

As IFC's development director I'm proud to report that, for almost 60 years, this community has raised a roof for safe shelter: from HomeStart shelter for women to SECU Community House for men. During those 60 years, private donations have supported 70% of IFC's revenue. Wow. Thank you.

Today we face a 40% increase (from 2020-2021) in homelessness in our County, and 73% of people experiencing homelessness (in our County) are people of color. Amidst this painful reality, IFC is a beacon of hope. A pathway to resources for our neighbors experiencing hard times.

On that chilly wet day in October, we did walk to the polls. As a group of us walked down Franklin to vote, a man from another IFC group shouted gleefully to us from Chapel of the Cross, "I just voted for the first time!" to which we all clapped and shouted in congratulations. Many of us did not know each other. But we were bound by our relationship to IFC and a commitment to uplift each other, empower each other. People find this kind of community at our shelters every day.

A gift to IFC is actually a gift to our neighbors who need resources. IFC cannot continue to depend upon private support for 70% of our revenue. We need government to be a true partner, to help create equity in our own backyard, to be sure IFC offers services for the long haul. Please commit public funds in the Town budget to sustain IFC's shelters.
