Good Day Everybody,

Tonight's Stormwater Advisory Review Board has gone totally virtual. I had wanted to comment in person, and illustrate, through photographs, the factual errors concerning the southern streams overlay(s) of the Gateway Concept Plan. I am not competent to deliver these photo's in an online meeting. Please allow me to submit several photo's here. I have more; but I believe these photos will adequately demonstrate my concerns.

Gateway Concept Plan Applicant maps C000, C100, and C101 are factually inaccurate (overlay, streamwise) on the southern side. The property boundaries are correct. I can demonstrate the approximately 90 foot southern line(s) error by the attached photographs. It's important to have the correct stream crossing at White Oak Drive. And the stream misalignment, when corrected, will move the stream onto applicants property on the Darden parcel. The first photograph is taken on the southern Darden/Smith east/west line. Looking north and west into the Darden parcel. This is the mid-point of the southern boundary of the applicants border. And, clearly shows an active stream passing thru the edge of the Darden parcel. Applicant maps C000, C100, and C101 incorrectly indicate this stream is about 90 feet south



Turning around facing east, northeast, the stream continues through the Smith parcel in a relatively straight line to the USGS merge of the northern stream. Where it then travels through fallen, storm ravaged, right-of-way to a pipe under White Oak.



Demonstrating the inaccurate Applicant maps once again. Now; going out on White Oak Rd; applicant proposes the creek passes thru the road incorrectly. At about the same error of 90 ft. The orange cone located in the foreground is the stream pipe under the road. And to the south, uphill about 90 feet, is a cone placed where applicant suggest the stream passes:



These are factual mistakes of great concern. We would like the mistakes corrected. And ask all governing bodies and boards to insist on corrective applicant drawings. It appears that the topographical contours and stream alignment overlays need work in the Applicant package. I also request the Town Staff to distribute this photographic evidence as appropriate to the various boards and bodies. Especially; to tonight's Stormwater Advisory Board meeting.

I am available at all times to work with the town, staff, or applicant.
