

Dear Mayor Hemminger, Town Council Members, Manager Jones and Director Vinas,

I hope this note finds you well. I am writing on behalf of the Homestead Housing Collaborative—CASA, Community Home Trust, Habitat for Humanity, and Self-Help—to share additional information about the status of the proposed

Homestead Gardens development as we seek a way to keep it moving forward despite unprecedented increases in construction costs and rising interest rates over the past couple of years. Please let me know if you have questions or feedback upon reviewing this message, as our development team would be happy to talk further.

The HAB-recommended funding allocation does not provide sufficient gap funds to the Homestead Gardens project to complete all the site work plus any single partner's element of the vertical housing development, so we do not see a path forward for this project without additional Town subsidy. We recognize that the need for affordable housing subsidy for projects in town is large and growing, and we hope that this message can serve as a starting point for a conversation about how the Town can support all the needed projects that we, as advocates for affordable housing, and the Council want to see completed. To that end, the Collaborative members are unanimous and clear that we do not want Homestead Gardens funded at the expense of Weaver's Grove, which is a high-impact, shovel-ready project that needs funding in this current cycle to move forward and that the HAB wisely recommended for funding.

In the view of the Homestead Housing Collaborative, there are three potential approaches to moving an affordable housing development forward at 2200 Homestead Road in the near-term, each of which is briefly described below. We hope this summary is helpful as Council determines if and how to continue to support the proposed Homestead Gardens development. The three options are listed in the Homestead Housing Collaborative's order of preference, from most desired to least desired:

#### 1. Pragmatic Approach (Partial Build + Future Phase).

• Build out sitework for the full revised scope plan of ~87 units, and have vertical partners build all housing except the 22-unit CASA workforce rental building in the initial phase (for a total of ~65 units).

#### • Key resources needed from Town:

- \$1.6M in additional funds beyond the \$1.8M that was recommended by HAB (\$3.4M total in Town funds)
- Support for retaining previously awarded funding for 65-unit, reduced-scope project with a future second phase
- o Support for CZ modification for 65-unit, reduced-scope project with a future second phase

#### 2. Ambitious Approach (Build the Full Revised Plan).

• Build the entire revised scope plan of ~87 units that we proposed as part of our funding application to the Town for the current ARPA/AHDR/Bond funding cycle.

#### • Key resources needed from Town:

- \$3.6M in additional funds beyond the \$1.8M that was recommended by HAB (\$5.4M total in Town funds)
- o Support for retaining previously awarded funding for 87-unit, reduced-scope project
- Support for CZ modification for 87-unit, reduced-scope project

#### 3. Start Smaller

• If less than \$3.4 million is provided in this funding cycle, the Homestead Collaborative will circle up and consider whether there is a feasible path forward, such as a smaller initial phase. Our team has a number of concerns about this path, since future funding sources for this and other affordable housing projects are not clear at this time.

Finally, for quick reference/context in case helpful, here is information on each Collaborative partners' leverage of non-Town funds. The percentages include the requests in the current funding application that the HAB considered:

- Self-Help (site work): 44% of funding for the site work will come from sources other than the Town of Chapel
  Hill, and this work needs to be 100% grant funded to not pass on site costs to the vertical partners and further
  increase their need for subsidy.
- Community Home Trust (townhomes): 75% of the funding for these townhomes will come from sources other than the Town of Chapel Hill.

- CASA Horizons: 79% of the funding for the Horizons building will come from sources other than the Town of Chapel Hill.
- CASA Workforce (apartments): 54% of the funding for the workforce apartments will come from sources other than the Town of Chapel Hill.
- Habitat (duplexes): Habitat is not asking for Town of Chapel Hill funds for Homestead Gardens in this application cycle.

Members of the Collaborative are available to discuss the options that we have outlined here in more detail before the Council considers the affordable housing funding plan on November 16.

Mayor Hemminger and Members of Council,

I am writing as a member of the Housing Advisory Board about two topics:

- 1. The recommended funding plan, and
- 2. The proposal for expedited review of development proposals that include 30% affordable homes

- Regarding the HAB's funding recommendations, I know Sue Hunter, the HAB chair, will make comments at the
  Council meeting. I would like to recommend, that prior to the Council meeting, Council members take time to
  review the video of the HAB October meeting, when we reviewed the funding applications. Viewing the funding
  portion of that meeting would help the Council to better understand the difficulty we had arriving at wellreasoned recommendations.
- 2. Regarding expedited review, I think the proposed ordinance revisions may well provide private sector developers with the incentives needed to produce affordable housing. My biggest concern is that 30% may be too high a bar, given recent increases in development costs. Hopefully, Town staff has received positive feedback to the proposed revisions from local developers, or from housing consultants. In any case, I applaud the Council for considering ordinance changes that have the potential to increase the production of desperately needed affordable housing.
