Dear Mayor Hemminger & Members of Town Council:

I submit the following correspondence to respectfully ask for your support in approving Item 22-0866 which would establish an expedited review process for proposed affordable housing developments. It is our opinion that approving this measure would have a direct and positive community impact as it will serve to encourage the development of more affordable housing units in the Town of Chapel Hill.

The Town of Chapel Hill, like numerous other cities/towns, has a severe lack of affordable housing options (both for-rent and for-sale) for residents of the community. As a result, many low-to-moderate income families are forced to seek housing options outside of Chapel Hill. The present zoning and municipal approval process discourages the development of affordable housing primarily due to the timeline and associated costs. Speaking from personal experience through my firm's efforts on the Jay Street project, the rezoning process, from start to finish, took more than 15 months, required approximately 30 neighborhood and advisory board meetings and cost more than \$100,000 in architectural and engineering work.

The Low-Income Housing Tax Credit ("LIHTC") program is the single biggest producer of affordable rental housing units in the United States. In North Carolina, the LIHTC program is administered by the North Carolina Housing Finance Agency ("NCHFA") through a highly competitive application process. Unfortunately, apart from several town-owned and non-profit sponsored properties, very few LIHTC funding applications have historically been submitted to NCHFA in Chapel Hill/Orange County. This, in my opinion, can be directly attributed to the lengthy (and costly) municipal approval process that presently exists in Chapel Hill.

One of the biggest hurdles created by the town's present approval process is that the LIHTC program has stringent Placed-In-Service ("PIS") deadlines that, if not met, put the tax credits and, more importantly, the developer/owner's ability to obtain future tax credits at risk. The timeline associated with the town's present approval process creates enough uncertainty in the PIS process, that it is, without a doubt, safer to seek LIHTC development opportunities in towns/cities that have a more efficient approval process. An expedited review process that requires less up-front development design and site engineering will almost certainly result in more developers seeking opportunities to develop affordable housing in Chapel Hill.

Finally, as a member of the Town of Chapel Hill's Housing Advisory Board and a developer who has been through the process, I can state firsthand that while the goal of the advisory boards is to provide useful

feedback, it is not uncommon to receive contradictory direction between boards. Furthermore, because the NCHFA funding process is so highly standardized, suggested changes at the advisory board level often conflict with the LIHTC program and, thus, creates challenges in the competitive funding process. Most of the municipalities in which we presently operate don't require the input of citizen advisory boards. Instead, they rely on municipal staff (and ultimately, a council vote) to ensure that a proposed development meets all of the municipality's stated goals and requirements. Removing the requirement that affordable housing developments must go through the advisory board process should cause significant reductions in the approval timeline.

In summary, while well intentioned, the Town of Chapel Hill's present review process inadvertently discourages the development of affordable housing under the LIHTC (and other) program(s). If Item 22-0866 is passed, an expedited review process should result in more affordable housing applications and, thus, an increase in affordable rental units that will serve low-income families and seniors living in Chapel Hill

Please vote to pass Item 22-0866.

I am writing to you to urge each of you to vote YES on the LUMO amendment to expedite development review for affordable housing in Chapel Hill.

I have been a regular volunteer with Orange County Habitat for Humanity since 2018. As volunteers we work on building houses at all stages of the process. We often work side by side with the future home owners as they contribute their required sweat equity hours. The home owners are very motivated and very grateful to partner with Habitat, as they participate in building their future affordable home!

As you know, housing is very expensive to build. It is challenging for Habitat and other builders who face higher construction costs and the added expense due to the often lengthy development review process. A slower, burdensome review process to build affordable housing worsens our community's housing shortage, especially for individuals and families with lower incomes. Delays raise building costs and decrease the number of affordable homes available each year. With fewer homes available, prices go up.

The proposed change to streamline the development review process will help affordable housing providers like Habitat to build urgently needed new housing units sooner. The ordinance also requires market-rate rentals and homeownership developers to include a minimum of 30% affordable units. This amendment is a critical change that can help to alleviate our local housing shortage.

Mayor Hemminger and Members of Council,

I am writing as a member of the Housing Advisory Board about two topics:

- 1. The recommended funding plan, and
- 2. The proposal for expedited review of development proposals that include 30% affordable homes

- Regarding the HAB's funding recommendations, I know Sue Hunter, the HAB chair, will make comments at the
  Council meeting. I would like to recommend, that prior to the Council meeting, Council members take time to
  review the video of the HAB October meeting, when we reviewed the funding applications. Viewing the funding
  portion of that meeting would help the Council to better understand the difficulty we had arriving at wellreasoned recommendations.
- 2. Regarding expedited review, I think the proposed ordinance revisions may well provide private sector developers with the incentives needed to produce affordable housing. My biggest concern is that 30% may be too high a bar, given recent increases in development costs. Hopefully, Town staff has received positive feedback to the proposed revisions from local developers, or from housing consultants. In any case, I applaud the Council for considering ordinance changes that have the potential to increase the production of desperately needed affordable housing.
