Ethics Statement

ETHICS GUIDELINES FOR TOWN ADVISORY BOARDS AND COMMISSIONS

Members of advisory boards and commissions shall not vote on any matter in which they have a conflict of interest or an interest which reasonably might appear to be in conflict with the concept of fairness in dealing with public business. A conflict of interest or a potential conflict occurs if the outcome of the matter being considered is reasonably likely to have a direct, substantial, and readily identifiable financial impact on the member. In addition, members of the Historic District Commission and Board of Adjustment, when these boards are hearing cases, serve as quasi-judicial bodies. Pursuant to General Statute 160D-109(d), members of these boards “shall not participate in or vote on any quasi-judicial matter in a manner that would violate affected persons’ constitutional rights to an impartial decision maker. Impermissible violations of due process include, but are not limited to, a member having a fixed opinion prior to hearing the matter that is not susceptible to change, undisclosed ex parte communications, a close familial, business, or other associational relationship with an affected person, or a financial interest in the outcome of the matter.” Any member who violates these Ethics Guidelines may be subject to removal from the board or commission. If the advisory board or commission member believes he/she has a conflict of interest then that member shall recuse himself/herself from voting on the matter. In cases where the individual member or the advisory board or commission establishes a conflict of interest, then the advisory board or commission member shall remove themselves from the voting area. Any advisory board or commission member may seek the counsel of the Town Attorney on questions regarding the interpretation of these ethics guidelines or other conflict of interest matters. The interpretation may include a recommendation on whether or not the advisory board or commission member should excuse himself/herself from voting. The advisory board or commission member may request the Town Attorney respond in writing.

What perspective(s) do you bring to the board(s), commission(s), committee(s) or task force(s) to which you are applying?

I grew up as a military dependent and have lived abroad in Europe and Asia as well as in more than a dozen states. My degrees are in Political Science, Economics Development, and Economics from California, Indiana, and Illinois. Now a 40-year resident of Chapel Hill and professor at UNC, I have lived within town limits including 5 years in rentals near the University and now 35 years as a homeowner in the Durham County portion of Chapel Hill. A labor economist by training, I worked on valuing benefits for manufacturing workers, researching and testifying for the Smart Start Childcare Legislation, and other issues that evolved into port planning for climate change. For more than the past decade as a Global Research Institute Scholar, I have traveled extensively to see and learn from other places about how to best communicate the water challenges of climate change from flooding due to severe precipitation, hurricanes, sea-level rise as well as droughts, wildfires, and health threats from extreme heat and contaminated floodwaters. In sum, I am very interested in the issues of stormwater, and transportation, and the collaboration between UNC and the Town in addressing problems proactively so that we can better build resilient communities.

I served from 1990 to 1996 on the Town's Transportation board including on numerous regional committees to develop the Triangle Transit Authority's plans for buses, rideshare, and rail service. I chaired the board for nearly all that time and was co-author of the Council requested "Single Occupant Vehicle Use" report that was used for the new CH planning initiatives for development throughout the 1990s. From 1996 to 2002 I was a Trustee (and served in all leadership positions) of the Triangle Transit Authority (now GO Triangle) as Chapel Hill's appointee. I have presented, researched, published, and teach primarily courses on local development with respect to infrastructure as it relates to important corridors ranging from transportation, utilities, and stormwater issues. I served 20 years on the UNC Buildings and Grounds Committee which advises the Chancellor on a wide range of issues related to campus development including stormwater management, transportation plans, and building-specific plans from physical accessibility, to landscaping on campus properties. I served on several "town-gown" committees examining University growth and the development of the "Carolina North" property. I have also audited many of the relevant UNC graduate courses in Planning and the school of Public Health, Marine Sciences, and countless local, state, and global conferences and training on water risks related to the built environment. For more than 30 years I have been deeply engaged in the public service mission of the University by developing UNC APPLES service-learning courses with community partners in the town, region, and state for my students to work with as part of individual or course projects. Many alumni have gone on to work for those non-profits, government agencies, and educational sites. In addition, I am a Thorp Public Service Scholar at the Center for Public Service, working on communicating water challenges through innovative strategies such as CLIMATOPIA with my students. We have developed a children's fabric board game to teach and provide resources on how to better plan for and recover from water disasters which will be distributed to environmental education sites statewide next year. We used the MakerSpace facilities on campus (BeAM) to design and produce it. I am deeply committed to community engagement and using the diverse skills and perspectives of all members of our community in problem-solving.

ETHICS GUIDELINES FOR TOWN ADVISORY BOARDS AND COMMISSIONS

Members of advisory boards and commissions shall not vote on any matter in which they have a conflict of interest or an interest which reasonably might appear to be in conflict with the concept of fairness in dealing with public business. A conflict of interest or a potential conflict occurs if the outcome of the matter being considered is reasonably likely to have a direct, substantial, and readily identifiable financial impact on the member. In addition, members of the Historic District Commission and Board of Adjustment, when these boards are hearing cases, serve as quasi-judicial bodies. Pursuant to General Statute 160D-109(d), members of these boards “shall not participate in or vote on any quasi-judicial matter in a manner that would violate affected persons’ constitutional rights to an impartial decision maker. Impermissible violations of due process include, but are not limited to, a member having a fixed opinion prior to hearing the matter that is not susceptible to change, undisclosed ex parte communications, a close familial, business, or other associational relationship with an affected person, or a financial interest in the outcome of the matter.” Any member who violates these Ethics Guidelines may be subject to removal from the board or commission. If the advisory board or commission member believes he/she has a conflict of interest then that member shall recuse himself/herself from voting on the matter. In cases where the individual member or the advisory board or commission establishes a conflict of interest, then the advisory board or commission member shall remove themselves from the voting area. Any advisory board or commission member may seek the counsel of the Town Attorney on questions regarding the interpretation of these ethics guidelines or other conflict of interest matters. The interpretation may include a recommendation on whether or not the advisory board or commission member should excuse himself/herself from voting. The advisory board or commission member may request the Town Attorney respond in writing.
