Dear City Council Members,

I am writing to you again as part of the New Hope Audubon Society whose mission is to promote the conservation and enjoyment of birds, other wildlife, and ecosystems, focusing on Chatham, Durham, Orange and parts of surrounding counties. It is with this

mission in mind that I am writing to you on behalf of our members in Chapel Hill and Orange County many of whom contacted you at the previous meeting regarding the Eastowne Development. We have been working with the town on a number of projects such as Leave Your Leaves and Lights Out Chapel Hill both of which help promote a more bird-friendly community. There is now an opportunity for the Council to help our birds and conserve parts of an ecosystem.

UNC Health Care is requesting to develop part of the Eastowne Natural Heritage Site. Their intentions are to potentially locate a 6-story parking deck in the middle of a 20-acre Natural Heritage site. This area (N20) is designated as a Natural Heritage site by the State of North Carolina and the NC Natural Heritage Program has documented the unique aspects of this forest. The mature hickory, oak and beech tree forests are important habitats for our birds and other wildlife. This area is also part of a contiguous wildlife corridor which is already connected to other preserved lands and part of the New Hope and Eno River Basins. It is not a suitable location for a parking deck especially as the slopes on the property are especially steep.

I realize that UNC Health has indicated a preference to not build this last parking deck. They have also recently indicated that they can increase each of the proposed parking garages within the inner Loop by 2-3 stories, which should help to alleviate future parking needs. Potential alternatives also include a future land swap with the Town if the Town could acquire property to support a parking deck near Eastowne. I'm not sure why UNC Healthcare would not be responsible for acquiring additional land for future parking needs.

I would ask you and other members of the Council demand that access to building on N20 not be included in UNC Health Care's plans and that 100% of this land be included in a conservation agreement. Until this land is protected, there will always be the possibility of development on it. In fact, this is also the recommendation of the Chapel Hill Environmental Stewardship Advisory Board.

The loss of biodiversity is recognized as being as devastating as the climate crisis to life on earth, as stated by the United Nations Environment Programme World Conservation Monitoring Center: "Climate change and biodiversity loss are twin crises that should be tackled together. Conserving, managing, and restoring ecosystems are key to success." The Council can do something about preserving biodiversity and fighting climate change by ensuring the N20 parcel is protected.

There are no objections to other parts of this plan other than development on the N20 parcel.
