Lagoo introduced the case. The property owner, Tyler Tomasik, presented his case to the Board and answered questions from members of the Board.

A motion was made by Strada, seconded by Hatley, to approve Resolution A - Granting the Variance, subject to an amendment proposed by Miller which would bar the property owner from installing any utilities in the shed. A super-majority being required to grant a variance, the motion failed by a vote of 5 ayes and 2 nays.
