Mayor Hemminger and Town Council Members:

As you know The Chapel Hill Carrboro Children's Museum (Kidzu) will be discussed at the Town Council meeting on Wednesday June 13. I kindly ask that you support Kidzu's request to further the partnership between Kidzu and our community.

Like many college town communities, Chapel Hill has one of the widest student achievement gaps in the United States. While there is no single solution to this gap, opportunities for childhood enrichment can be one part of a larger approach to addressing this challenge. Children's museums like Kidzu provide this kind of child enrichment outside of the traditional classroom.

Together with our library, afterschool programs, community Pre-K, community centers, Food for the Summer, and other programs and services, Kidzu is part of the fabric of resources that serves the children of our community. However, Kidzu can do more. Kidzu is constrained by the space available at the current location. Additional space would enable Kidzu to serve more children with deeper enrichment. And Kidzu is currently in a commercial establishment. This may have some influence on the demographics of the families that visit Kidzu. If Kidzu were in an easy to access but non-commercial location this would enable Kidzu to reach an even broader cross section of our community than it already serves.

As leaders in our community I realize that you have finite resources to address competing priorities. Outside of the benefits to children The Chapel Hill Carrboro Children's Museum conservatively estimates that a new children's museum would attract 200,000 visitors annually. These visitors would provide an economic impact of almost \$4,000,000 per year, and the new museum would provide over 55 direct and indirect jobs for our community. Additionally the site that Kidzu is inquiring about is not far from Chatham County. A new museum at this location would likely attract many visitors and their tourist dollars from Chatham County.

I am writing to ask that you support the request by The Chapel Hill Carrboro Children's Museum (Kidzu) to negotiate for the provision of space for a new Children's Museum at 100 Sumac Road. The space would be used for a new museum to expand the services Kidzu already provides to our children. This request is an opportunity to combine tourist revenue, new jobs, and child enrichment for our community.

Many claim that the best way to address student achievement gaps is to never let them open in the first place. A rightsized, thoughtful, and well run children's museum in a space that welcomes our whole community can be one of the tools that helps us reach that goal.

- 1. It is in Chapel Hill and we want to keep Kidzu in Chapel Hill.
- 2. The Southern Village neighborhood and Village Center will be great neighbors and partners for Kidzu. The neighborhood is teeming with children (always children grow up and more come). Scroggs Elementary School and Chapel Hill Day Care are close by. Many activities that are scheduled on the Village Green might dovetail with Kudzu's programming and mission.
