The Parks and Recreation Department recently shared that they are looking to convert previously dedicated open space. They stated they want to reforest much of it and we (local neighborhood residents) believe it will become swampy forest areas - similar to the adjacent lots on Cleland.

We would like to have additional discussion and experts weigh in on this decision, as we believe it will impact localized flooding, the safety of residents (especially those who walk and run), aesthetics, and it is completely counter to the original intent of the space. It was dedicated to being "preserved open space for the citizens of Chapel Hill" years ago.

We've captured over 140+ signatures from Chapel Hill residents who live on or near the area identified who are against this change.

Please stop the plans to reduce mowing and reforest.

Oakwood / Cleland / Rogerson / Oaks Neighborhood Residents Concerns with Proposed Parks and Recreation Plan to Reforest Open Spaces

1. Communication to the Residents of the surrounding areas of the Cleland Open Space Areas was minimal in August 2018. Information did not reach the majority of homeowners and residents until later in October 2018. Once information on this project reached more of the residents, there has been an overwhelming response to keep the Open Space as it is. (The Petition has 165 signatures as of 12/5)
2. We believe minimal resident input was used to determine options on how to move forward. There was a deadline to return comments by 9/14/2018, which a majority of us weren't even informed about. At the Park and Rec meeting we were told the results were:
 - 14 were for reforestation
 - 6 In between
 - 11 were against reforestation

We believe a compromise document was written by Parks & Rec using this 31person input, before the public meeting. This document was circulated to a smaller group. Many residents never saw this info until November. Once informed, approximately 20+ Residents immediately wrote in on 11/11 right before the meeting on 11/13. Parks and Rec stressed at the meeting it was not a vote, but they used these numbers to move forward with the project and to write the compromise.

3. A significant majority of the residents feel very strongly about saving the Open Space as it was originally intended. To manage the beautiful unstructured open fields back to a usable state so that the many families can continue to enjoy this space as we had up until just a few years ago.
 4. Please request copies of the letters written to the Parks and Rec committee by the 3 Families (Bells, Lloyds and Kolks) originally involved in the sale/dedication of the Open Space. This space was dedicated with very distinct guidelines that the town keep it as an area of residents to have as usable Open Space.
 5. Please do not use the clear-cutting of other areas in Chapel Hill as a rationale for converting our Open Space to create tree canopy lost in other parts of town.
-
