Hello,

I hope this email finds you well. My name is Allison, I am a graduate student at UNC and a resident of Chapel Hill. For the past year, I have been volunteering with the Orange County Food Council's Food Access workgroup. Through the workgroup's monthly meetings, different participating stakeholders (individuals and organizations) who are dedicated to improving access to healthy food for all Chapel Hill residents have built relationships and found opportunities to collaborate. For example, the workgroup put together a resource guide inventorying all of the food assistance programs that Chapel Hill residents have access to. This coming year, we will address food security in Chapel Hill through access to higher wages as well as improving farm to school initiatives.

I understand that today the Chapel Hill Town Council will be bringing up the Food Council's MOU. Unfortunately, I will not be able to make it to the meeting in person, so I am writing to express my support for funding full-time coordinator position for the Food Council. The Food Access workgroup has ambitious goals for 2019, as do the other two workgroups (local food economy and food waste) and the Food Council as a whole. While I am happy to volunteer my time, I can only do so for one of the projects in my workgroup. The Food Council has many volunteers like myself who are passionate about building a more equitable and sustainable food system here in Chapel Hill. However, we require someone who is able to dedicate their full attention to coordinating our efforts – as volunteers, we lack the time to manage our projects as part of a larger effort. The ability to maintain relationships with and connections between a diverse group of stakeholders and volunteers – or the ability to be an organizer - requires tremendous time and a flexible schedule. Furthermore, the ability to coordinate multiple projects and network and learn from other food councils in North Carolina requires an individual who is highly motivated, organized, and knowledgeable about food systems. As a former Peace Corps Volunteer (read: community organizer), I know that a volunteer, or even a part time coordinator, cannot be expected to fulfill these responsibilities. As a former outreach worker at a community health center who served on a council with diverse stakeholders, I have also seen a successful community collaboration flounder when the fully-funded coordinator position was eliminated.

The food system doesn't just affect farmers. One of my favorite parts of having moved to Chapel Hill is the connection I feel to our local farming community, which makes me a healthier and more conscientious consumer. Supporting local farmers and businesses that source from local farmers keeps the money I earn at UNC within Chapel Hill and Orange County. As a volunteer at the Interfaith Council's Community Kitchen, I've also seen how a systems approach to food waste and food access impact this community's most vulnerable.

Supporting the Food Council will strengthen our local food system, contributing to the growth and resilience of our local economy, reduce our impact on our environment and ensure that our residents have access to affordable and healthy food. I hope you will strongly consider agreeing to the MOU to fund a full time coordinator position. Our community will be stronger for it.
