New Business**2. 1200 MLK Concept Plan**[\[19-0112\]](#)

Key points made by members of the Housing Advisory Board during its review of a concept plan for 1200 MLK include:

- Would like a formal commitment to keep lot rents at an affordable level - 50% AMI and below
- Recommend the developer to continue holding meetings with the residents to address resident concerns
- Believe it's a positive if all the homes can stay on the land
- Concern with a 3-story building in close proximity to the homes
- Critical to establish fencing or some type of separation between the self-storage and residential area
- Recommend only allowing access to the building on the MLK side of the self-storage building
- Recommend looking in to whether there is a need for self-storage in this location

Additional Notes:

- 30+ residents in attendance; 3 residents signed up to speak. The speakers expressed concerns around: keeping the rent affordable on the site, renewal of lease contracts, longevity of being able to stay a resident of the site, safety and security of residents, particularly families with children if there is open access to the community from the self-storage facility, and incorporating fencing and buffers between the storage facility and the homes.

3. Exploration of Affordable Housing Strategies in the Blue Hill District[\[19-0113\]](#)

Staff presented an update on their exploration of strategies that could assist in reaching the Blue Hill District affordable housing goals and received feedback from the HAB.

funding.
