## **Approval of Minutes**

**1.** January 22, 2019 Meeting Minutes

A motion was made by Kastrinsky, seconded by Kjemtrup-Lovelace, to approve the January 22, 2019 meeting minutes. The motion carried by a unanimous vote.

## **Old Business**

2. No Right on Red

Kumar Neppalli, staff, provided additional information requested by the Board at a previous meeting on level of service categories and pedestrian counts at various intersections in Chapel Hill. The Board approved the list of

intersections as recommended by Staff, and discussed appropriate timing for No Right on Red, and unanimously approved the item with the modification that right turns on red be prohibited at all hours of the day.

#### **New Business**

3. 15-501 Side Path

Bill Webster, staff, presented an overview of the proposed 15-501 sidepath. Several members of the public spoke, expressing concerns about safety where the path would cross Ridgefield Road and Walnut Street, and proposed an alternative of installing shared street improvements on Hickory Drive. Staff intends to study the feasibility of this alternative as project design proceeds and is currently adapting the contract with the consultant to address safety concerns, and is seeking a third party expert. The Board determined that the item should be included on the next meeting agenda for continued discussion.

**4.** Electric Scooters

Sarah Poulton, staff, presented an overview of the Town's work with GotchaBike on electric scooters and challenges and opportunities if the Town were to allow them. Board members discussed issues that might arise with the use of electric scooters, including sidewalk clutter, safety, the use on greenways and other areas, and challenges associated with the Town's topography.

**5.** SPOT 6.0

Corey Liles, staff, presented on SPOT 6.0, a process used by regional partners to identify and prioritize proposed transportation projects for state and federal funding, and described previously submitted projects and projects that could potentially be added or removed from the list. Board members were generally supportive of the recommended changes to the list. A member of the public expressed concern over the removal of a proposed pedestrian bridge over Fordham Blvd from the list. Board members then discussed the merits of pedestrian bridges and were generally supportive of keeping the project on the list. The Board determined that the item should be included on the next meeting agenda for continued discussion.

6. Rogers Road Update

Corey Liles, staff, presented on the Rogers Road Zoning Initiative, an effort to establish new zoning standards for the Rogers Road Area. The Board was invited to attend a Joint Advisory Board Meeting on March 19, 2019 to learn
