Attached is my public comment to the Town Council committee members. Thank you for the opportunity to address the Council.

I am here to discuss the need for affordable housing in Chapel Hill and specifically the parcel of land, 220 Homestead Rd.

I am the parent of a 34 year old young man whose name is Brian. He has two part time jobs, he volunteers for Habitat for Humanity and he is a photographer who has had his photos exhibited in numerous art shows. He is known for his sense of humor, his empathy and his willingness to help. Oh, and by the way, he has autism.

The majority of his life has been in inclusive settings, starting from elementary school through high school graduation, and in his jobs. He thrives when he is surrounded by a diverse range of people. He is unable to live independently due to the limits of his disability and because he is on the waiting list for the Innovations waiver where he is joined with the other 12,000 people in North Carolina. As a result of not receiving the waiver he continues to live at home with his parents. This is not an appropriate setting for a 34 year old and this lack of housing options continues to limit the quality of life that he deserves and that we, his parents, who are in our golden years, deserve. My husband and I have not been able to take a vacation together for over 20 years due to the lack of supports.

I am one of the four founding members of HOPE, which stands for Housing Options for People with Exceptionalities and I would like to share our vision with you:

HOPE's vision: To create an inclusive community where all individuals, including those with developmental disabilities, can live a meaningful and purposeful life.

And now I would like to share **Chapel Hill's Vision** for affordable housing, as expressed on your website:

A vibrant and inclusive community where all residents have access to affordable housing and opportunities to thrive.

Chapel Hill's mission is to:

Creating partnerships, catalyzing affordable housing and building community.

As you can see, we have a lot in common! We hope that we can collaborate with the town of Chapel Hill in providing affordable housing options for our most vulnerable populations, which include individuals with disabilities.

I would like to end with this, I cannot take credit for writing it but it is reflective of many of the parents we represent.

"Every parent plans to raise their child for about 18 years, set them free for 30 years and then hope they come back to help them face the final years of their own life. A SPECIAL NEEDS parent plans to raise their child for 65 years and while doing so also has to prepare for the other 20 or so after they themselves are long gone. Let that sink in for just a moment and you will begin to understand the drive and determination that many of us have while we are here on earth."

If you have never thought about that, don't be sorry, be thankful.
