Chapel Hill Pickleball Input for Feb 12, 2020 Town Council Meeting

Thank you for purchasing the Legion Property and considering the development of this space into a Park for the benefit of the town. We believe protecting this last large parcel in Chapel Hill for today's and future generations recreational needs is critical. We are especially supportive of your efforts to help build facilities that promote **healthy lifestyles** for our citizens.

We (gesture to our group) are members of the Chapel Hill Pickleball organization. We work closely with Parks and Recreation to bring pickleball to the Chapel Hill community.

We want to advocate for pickleball being park of this envisioned Legion Park space. We believe including pickleball is important to Chapel Hill for many reasons:

- Pickleball has become an extremely popular sport. It has been the fastest growing sport in the US for the past 10 years.
- Pickleball is the perfect example of a lifetime fitness sport that supports healthy living. It can be played by all ages, and is fun for everyone.
- It is a uniquely inclusive sport, which brings together a diverse group of players.
 There is minimal cost to participate, and everyone is welcomed. First time players rave about what a positive environment we have in Chapel Hill. We have 8 year olds playing with 80 year olds. We provide free training, teaching, leagues, and tournaments.
- We have the largest number of participating players of any sport in Chapel Hill using Chapel Hill facilities.
- Because Pickleball is a relatively new sport, with explosive growth, we have very limited facilities. The only dedicated Pickleball courts are at Ephesus Park, where there are 6 pickleball courts (the same size as two tennis courts).
 - 2013 we had 12 active players
 - 2015 about 165 players
 - 2017 about 500 players
 - 2019 over 850 players
- The growth in pickleball in our community has been steady. As projected we
 have outgrown the Ephesus courts (opened in 2017). We often have 30-40
 people waiting their turn to play.
- To have the capacity to meet the projected demand in Chapel Hill for pickleball courts we will need to add 24 outdoor courts and 9 indoor courts within 5 years.
 It is important to build a single complex that builds community around the sport, and supports activities like leagues and tournament play.

 If we are able to build a proper sized Pickleball Complex in Chapel Hill, we will be able to host large tournaments, which brings overnight visitors to Chapel Hill, and would bring in tens of thousands of dollars in revenue to the town. The Visitor's Bureau is supportive of this and their consultant recommended a larger (32 court) complex.

Legion Rd is the last large park space developable by the town of Chapel Hill. It is the perfect location for park space, and for constructing a Pickleball facility that will support a healthy lifestyle and meet the needs of our community, for the next 10-20 years.

As you plan for this facility, we encourage you to take time to listen to your community and its needs for this wonderful park space. We look forward to working with the town on this.

Dear Mayor and Town Council (Cc to Town Manager Jones),

My wife Amy (Ccd) and I understand that the Council will re-start conversations around how to plan for future development of the American Legion #6 parcel at this week's work session. We are writing to make sure you are aware of Studio A DanceArts, an existing woman-owned small business on the site, in hopes your staff will work hard and be creative, in order to try and retain Studio A as plans develop.

For years Studio A DanceArts has been housed in a structure near the back of the Legion site (to the left and behind the Legion post as you drive into the site). It's a simple facility but has a loyal following because of the wonderful dance community the owner Melody Eggen and her teachers have created for children from the adjacent Colony Woods neighborhood and from across the county and beyond. My older daughter has been a student at Studio A for four years and absolutely loves it. Our family truly hopes Studio A will remain at Legion Road, or at minimum be given plenty of time to find a comparable location elsewhere in town.

As the Town's lease back to the American Legion expires in the months ahead, I hope the Town will enter into a lease directly with Studio A to keep the business open at minimum through the time redevelopment of the land begins, which presumably will be years in the future. I think this would be a win-win for the Town to maintain a small local business, while earning some modest revenue. I am sure Melody would welcome a visit to the Studio from any of you if you'd like to talk with her directly to learn more.

I truly appreciate your consideration, and please let me know if I can be of any help in furthering these discussions.

I am Sarah ___, I have lived in Chapel Hill since 1985 on Caswell Rd and I am a long time International Folk Dancer here, belonging to two dance clubs, located in Durham and the IFD of Raleigh (which is an integral part of their parks and rec program, also meeting 50 weeks of the year). I have also served Chapel Hill on transportation and planning initiatives, like the Central West planning initiative, with an interest in developing more infrastructure for pedestrians, bus riders, and cyclists. I have also been vocal about Chapel Hill reducing distances between destinations, as a means to better achieve multimodal transportation, to reduce our carbon footprint, to reduce storm water flooding, and to facilitate higher density mixed use, to turn Chapel Hill from suburbia into an association of several neighborhood villages. In that context, I am interested in getting neighborhood multi-use social halls, with some of these being spaces appropriate for social dance.

Personally, I drive 3 hours a week to Durham, Chapel Hill, and sometimes Carrboro, to go to other communities to participate in social dance. I haven't been able to attend social dance here in Chapel Hill for over 20 years, and these dances clubs I belong to haven't been in Chapel Hill in 25 years now. I had to stop dancing on the Seymour Senior Center basement fitness floor because it was sticky, with no give, because it is sprayed sticky stuff on concrete. The monthly Scandinavian waltz group there continues to meet, but only a handful of people will dance on that floor. Several have ended up with twisted knees and ankle problems. I have artificial knees and hips and do not care to risk injury dancing on a bad surface that is toxic to all social dancing. Young bodies might be able to use that floor for Indian Temple dancing or basketball, but this floor is totally unsuitable for continuous bouncing and turning maneuvers. As having worn out my knees and hips from walking on hard surfaces all around Chapel Hill, I recommend we start designing better surfaces for human movement. The ideal surface for human dancing is a floating (sprung) smooth hard finished wooden floor. It can't be concrete. It can't be rubber, and it can't be wood laid directly on top of concrete (as the town's multipurpose buildings at Estes Hills and Glenwood elementary schools).

My current, new project is for Chapel Hill to build at least one public dance hall space, with the appropriate flooring and situation for long term dance club use. I intend to spend whatever time is necessary to achieve that goal.

This past November, the Chapel Hill International Folk Dance Club met in the Carrboro Century Center to celebrate 55 years of existence, meeting once a week for 50-52 weeks of the year. We had 160 people, some from out of town and state, meeting to dance from 11 AM to 11 PM. At this time, we also officially changed our name from Chapel Hill International Folk Dance Club to Durham Chapel Hill International Folk Dance. This former Chapel Hill recreation has been meeting in Durham for 25 years now. There were several of us who were wanting to remove Chapel Hill from the name entirely. Afterall, why give Chapel Hill any credit for providing social dance when there isn't a dancefloor anywhere in Chapel Hill?
